Madam,

I am directed to refer to your online RTI applications bearing Registration No. MHUPA/R/2017/80140/1 & No. MHUPA/R/2017/80140/2 dated 09.08.2017 which have been received in the office of CPIO (HFA-IV) on 17.08.2017.

2. In so far as CPIO (HFA-4) is concerned, the requisite information is furnished as under :-

Point No. 1, 2, 6:- Do not concern this division. RTI application is transferred to the concerned public authority.

Point No. 3, 4, 7 & 8:- The requisite details of Slum development programmes undertaken by the Ministry, are as under:

(i) Rajiv Awas Yojana (RAY) envisaging slum-free India was launched in June 2011 in two phases; the preparatory phase for a period of two years which ended in June 2013 and implementation phase. The implementation phase of RAY was approved as a Centrally Sponsored Scheme on 3.9.2013 for the period of 2013-2022. Under the scheme, Government has extended central assistance of 50% of the project cost for Cities/ UAs with Population more than 5 lakhs, 60% of the project cost for Cities/ UAs having population less than 5 lakhs and 80% of the project cost to cities in North-Eastern Region and special category States (Jammu & Kashmir, Himachal Pradesh & Uttarakhand) irrespective of their population. The Government has discontinued Rajiv Awas Yojana (RAY) and subsumed in the Pradhan Mantri Awas Yojana (Urban) (PMAY(U)) mission the liabilities created under 183 RAY projects where work had started on ground within 31.03.2015.

(ii) The Pradhan Mantri Awas Yojana(Urban) Mission, launched on 25.6.2015, aims to provide assistance to States/UTs in addressing the housing requirement of the slum dwellers and other urban poor. 'In-situ' Slum Redevelopment (ISSR) is an important component under PMAY (Urban) mission under which State / UT Government using land as a resource may take up Slum redevelopment projects for providing houses to eligible slum dwellers. Under PMAY(U) Mission, all statutory towns as per Census 2011 and Statutory Towns notified subsequently are eligible for coverage under the Mission. States/UTs also have the flexibility to include the Planning Areas (to the exclusion of rural areas) as notified with respect to Statutory Towns and such Planning Areas (to the exclusion of rural areas) as notified by Development Authorities.

As part of the information sought under the aforesaid points of your RTI application also falls in the domain of Housing Division of the Ministry, your application is hereby transferred under Section 6(3) of the RTI Act, 2005 to the concerned authority with the request for appropriate action under the provisions of the Act and furnish the information directly to the applicant.

Point No. 5:- The information sought falls in the domain of HFA-3 Division of the Ministry and the RTI application is already transferred to the CPIO concerned.

3. If not satisfied with the above information, an appeal shall lie with the Appellate Authority within 30 days from the receipt of the letter. The name and address of Appellate Authority is as under:-
