SUBJECT:-Complaint and Information required under RTI ACT 2005

Respected Sir/Madam,

This is drawn for your kind consideration and further information:-

1. That the matter pertains to **Indira Nagar Delhi-110033(North-West Delhi, Civil Lines Zones/Ward No.14 MCD)**.
2. That there are two Parks in the said locality i.e. Indra Nagar main Park (Mother Dairy Park) and Mahila Park (Dispensary park). That the main park is also used and occupied by the **Tempos/Trucks/and other commercial vehicles belonging to the Tent Market Shopkeeper and shop named M/s Prince Egg Mart Situated at Property No. A-53 Indra Nagar, Delhi-110033 (the whole seller of Eggs in the Residential Area)**. Moreover, the Tent Market shop-keepers keep drying and lying their material (such as Carpets, Shamiana and other material).
3. That the residents had preferred and filled many complaints and RTIs against the same to the concerned departments and authorities (such as MCD, Delhi Police, PWD Etc.) but all in vain and no action has been taken yet.

Therefore, I request you to kindly look into the matter and get it investigated by senior officials of your department as this **parking mafia/nexuses** is being run in the locality under the support from the concerned authorities and department and take some legal and disciplinary action against the culprits.

4. That there is **Another park** which is adjacent to the **MCD Dispensary** in the locality commonly known as the **MAHILA PARK, Indira Nagar, Delhi-110033**. The caretakers or Mallies named **Sh. Surat Singh, Sh. Chaudhary and Sh. Brijesh Kumar** who otherwise are taking good care but they are unable to stop the Gamblers playing cards in the park and fighting throughout the day with filthy & abusive language. It is not

possible for ladies to even to go for walk or kids to play or even the residents facing the park to stand in their balconies.

- 5. The Parks are not usually cleaned unless some Politician like Dr.Harshvardhan or Ms.Garima Gupta(Counsellor) of the area is visiting. The caretakers or Mallies named Sh. Surat Singh, Sh. Chaudhary and Sh. Brijesh Kumar are not doing their duties properly. The Trees grown on the corner sides of the Park are overgrown to an extent that is causing obstructions to the Road and Posing Danger to the Residents of the Locality as the same are passing through the NDPL wires. Even the overgrown branches of the Trees have started entering the Corner Households too. The Residents of the Locality have preferred numerous complaints and RTIs to the authorities/MCD/Horticulture dept. / Forest Dept. but all in vain and No remedial measures have been taken yet.**
- 6. That the Children of the area does not have any other place left and choice to play outdoor games as the parks are occupied by used by the Gamblers, Drug Addicts and Drug Paddlers.**
- 7. That the old age and female residents of the said locality are the main sufferers as they can't go and sit in the so called Mahila Park even where almost the whole day the Gamblers/Drug paddlers/Addicts keep on sitting. The ambiance remains so dirty and it is like Fish market.**

Therefore, you are requested to Kindly mark my complaint cum RTI to the concerned department wherever applicable as per the provision of RTI ACT 2005 as Even the Local Police station Adarsh Nagar has also been sent many complaints and the same had been reported to SHO of Adarsh Nagar Police Station and the concerned Beat officer of Delhi Police by the local residents but no corrective action has been taken.

Kindly provide me with the following details:-

The following was the subject matter of my RTI.

Kindly let me know the following details under RTI ACT 2005:-

1. How often/ How Frequently the parks are being cleaned and where the records of the same is maintained?
2. How many Care takers/ Mallies are assigned the work to look after the park?
3. How frequently they visit the said parks and where is there attendance being monitored and recorded?
4. How many plants have been planted in last 6 months in the said park?
5. **What is the maintenance protocol i.e. How frequently Grass cutting, Punning, Cutting of unwanted plants, watering, cutting of unusual growth of the trees/cutting of unusually spreading and not needed branches of the trees are done.**
6. What was the last time the maintenance of the park was done on said parameters i.e. How frequently Grass cutting, Cutting of unwanted plants, watering, cutting of unusual growth of the trees/cutting of unusually spreading and not needed branches of the trees.
7. Why the cutting of unusual growth of the trees/cutting of unusually spreading and not needed branches of the trees not done for last more than one year?
8. How many swings for kids have been installed in last 3years?
9. How much amount have been spent on the said parks in last one year for development or improvement?

10. Who gets the amount or who is responsible for the expenditure on the maintenance of park i.e. MLA/Counselor or some other officials?
11. How much budget is given/ allocated to the said park for maintenance and development of the said parks every year?
12. How much budget has been allocated and spent in last 5 years?
13. Kindly furnish the details of the name of the office, names and designation of the **officials', Mallies/Caretakers** under whose supervision does Indira Nagar Parks Fall?
14. Kindly furnish the details of officials allowing the commercial Vehicles like **Truck, Tempos being parked** inside the park?
15. Who are the officials involved in allowing the **Tent Mafia** to run and keep the materials used for Tenting the Park in the park itself. Kindly furnish the **names, designation, reporting manager, their contact details and timings of the officers/caretakers** who has been allowing the said illegal activity for the reasons best known to them.
16. Kindly furnish the **Details of law/by law/notification of the Govt./honorable court about the conversion of park (Govt./Central/State) into commercial activity like Parking Purposes.**
17. Kindly provide a list of **all infrastructure available and future plans for the said park.**
18. If the record is untraceable, who are the Officials responsible for not maintaining the same?
19. If you cannot give the whole information demanded by me, please give a part of the information which can be given according **to section 10 the RTI Act 2005. Section 10** of the Act allows those part(s) of the record which are not exempt from disclosure and which can reasonably be severed from parts containing exempt information to be provided.
20. If the information sought by me cannot be given to me please give me the certified copies of **the laws/bylaws/order/circular/notification etc.** under which such information is forbidden to the public.

21. That If any preventive measure has been taken to stop and deter the said activity by any of the above stated departments kindly furnish the details.
22. That If no preventive measures have been taken to stop and deter the said activity any of the above stated departments. Kindly furnish why is it happening under the nose of various departments and kindly recommend the matter for scrutiny with regards to the negligence or other reasons like corruption.
23. That If you cannot give the whole information demanded by me, please give a part of the information which can be given according to section 10 the RTI Act 2005. Section 10 of the Act allows those part(s) of the record which are not exempt from disclosure and which can reasonably be severed from parts containing exempt information to be provided.
24. That If the information sought by me or any part of the information does not pertain to Delhi Police, Delhi Jal Board, PWD, MCD, Horticulture, Delhi Fire Service, Land & Development, Delhi Pollution Control Department, Delhi Police Vigilance Department, MCD Vigilance, Counselor of the Locality, MLA, MP and other office kindly transfer the same to the concerned department/office within the stipulated time frame as prescribed by the RTI ACT-2005.
25. That Kindly furnish me with the details of the name of the office, names and designation of the officials', involved from the said departments under whose supervision/Jurisdiction does the said locality falls.
26. That Under which ACT/Publication/Right/provision/Sec./Sub-Section the permission has been granted for the construction of the said property.
