- 5. Kindly provide the certified photocopies of the decisions/file notings/minutes of the meeting of Departmental Screening Committee held on 28/08/2001 whereby ACP benefit was denied to me.**

- 7. Please intimate the action taken on my representation dated May 19, 2003 (Copy enclosed). If no action taken was taken, kindly intimate the reasons therefor.**

8. After coming into force of ACP Scheme dated 09/08/1999, please intimate as to when first DPC was held for grant of benefit thereunder in NIHFV by also revealing the names of beneficiaries.

9. Was my name considered in such first DPC as asked in Item No. 8 above.

10. Kindly intimate the number of DPCs held between 1999 to 2002 and the beneficiaries thereof. Whether applicant's name was considered during the aforesaid period and please also communicate the result thereof.

11. Kindly provide the copies of all ACRs considered for grant of 1st ACP to me vide order dated 02/01/2004.

12. Kindly provide the copies of all ACRs considered for my promotion to UDC vide order dated 23/12/2010.
