(After Giving The Three Rounds Of Interview i.e In Written Test and Face to Face Interview and Technical test and Also That After doing The Difficult task assign to me and in The More than nine months working with the department and In the Tmis software which is Completely in architecture and Their Coding Standerd is not upto the mark and The Project is Working for More Than Three Years but After That The Project Level is Not Upto The Mark and In the Previously I have send the letter in the DC(Training Division ).That The project is non-architerture even if The Project is not Functional when I visit in Chennai in the Mean time I have seen that HR Page is not working but they Gives to The confused to the department that net is not working and The project Flow is not working because there is the various error in the page

(But First Letter I get from the administrative department for three months and In that letter they mention that after the Performance Your Contract is Extended

Then I Got The Next Letter from NIHFW for Six Month on the Basis of Performance).

1.2) If The Extended Letter is also Given from The Ministry of Health Affairs Then Why NIHFW gives me Non-Performance Letter
