**Subject : REQUESTING FOR THE URGENT AND PROPER TREATMENT FOR MY FATHER DUE TO CARELESSNESS OF DOCTORS IN AIIMS.**

Respected Sir,

Hello ! Hope you are in hale and healthy condition Happy to see you, in doing welfare the country.

I Shimpy Arora C/o Mr. **Subhash Chand Arora**, who is **Senior Citizen aged 69 years**, R/o H-14, Masjid Moth, Greater Kailash Part-2, New Delhi-110048 beg to state that my father is registered in AIIMS under **UHID No : 102540838**

He underwent to surgery on 3<sup>rd</sup> January 2017 (Elsewhere – Indian Spinal Hospital Vasant Kunj New Delhi) of lower limb right leg and brought here in AIIMS on 29<sup>th</sup> of January, 2017 for further management under Prof. Shah Alam Khan Ji (Ortho-Surgeon Unit II), where first he was diagnosed with "OSTEOSARCOMA". We were sent to Medical Oncologist to Asst. Prof. Sameer Rastogi Ji where again all the Blocks / Slides got reviewed, even core biopsy has been done and reported as "MYOSITIS OSSIFICATION" (Benign Tumour). Till then, we are just shuttling here and there (from Jan. 2017 to Aug. 2017) and getting no proper treatment, in between being sent to private hospital for other opinion by Dr. of AIIMS only. Then again come back here in AIIMS. Now, Last week on 11<sup>th</sup> of August, he (my father) make complaints of

- 1 SHORTNESS OF BREATH
- 2 MINOR CHEST PAIN

I bought him to emergency, where the findings are of "PLEURAL EFFUSSION". Now, the doctors are saying that it has got "METASTASES" (No sample of fluid has been taken yet). MRI has been done on 17<sup>th</sup> April 2017 (in AIIMS only). His skin of leg has got "totally burned" during MRI (as there is fixation of plate, eleven screws, two cement balls). No report is ready yet, no MRI films (after Contrast) had been given to us. Even I have bought my father in O.P.D. of Prof. Shah Alam Khan Ji four times in Last month but he has not seen the patient (my father), just make it linger on "Come on Wednesday, Come on Friday" with his sayings.

My father was lying on stature outside the O.P.D. My mother and I went inside in his O.P.D. and he Insulted (Dr. Khan) the two of us in a very awkward manner, didn't listen to our problems and instructed us to get out from his O.P.D. Our O.P.D card from that day till date is unfilled but we are regularly making the visits but failed.

Now the questions are :

- 1 If the tumour is benign, how it has got metastates ?
- 2 Why Prof. Shah Alam Khan (Even S.R.) is not seeing the patient and lingering on the case in last three to four visits ?
- 3 Why the MRI films (of after Contrast) and reports of MRI has not been given yet ?

Only whatever the help I am getting is from Dr. Sameer Rastogi but sometimes he also get restricted.

Sir, now what I need, the need is the "HELP" from you so that my father should be treated properly in right way. Yesterday (on 16<sup>th</sup> August, 2017), **I HAD MAILED PROF. RANDEEP GULERIA, DIRECTOR OF AIIMS BUT GET NO REPLY.** He is not a dummy as AIIMS making experiments on him, he is a human being who should be treated with proper care attention and medications.

A daughter's begging you with her folding hands to make treat my father as soon as possible. Due to surgery. He is unable to walk, just on bed for last eight months, we manage to take him to AIIMS in ambulance. He is the breadwinner of our family.

Hope, You will look at the above matter with earnest consideration and do your best as soon as possible. My eyes are curious to see for forward and positive reply.
