2. I am in need of information/document specified below in relation to the following:
 - a. NH 208 was given new NH number 744 by notification dated 4th April 2011 by S.O No.689 (E) published in the Extraordinary Gazette on 4th April 2011. Likewise NH 17 was given new NH number 66 by notification dated 4th April 2011 by S.O No.689 (E) published in the Extraordinary Gazette on 4th April 2011. It is appears that the NH 208 and NH 17 were originally included in the schedule to the National Highways Act long prior to said S.O dated 04.04.2011. You are requested to inform me as to how and when the said NH 208, and NH 17 were originally included in the schedule to the National Highways Act and the S.O number and the dates of the notifications relating to the same. You are also requested to give a copy of the notifications said to be issued in

A true photocopy copy of entire file containing all the notes/notings/orders/decisions of all the Officers/ authorities including notes/noting/order/decision/approval if any of the Minister for Road Transport and Highways ,Government of India relating to notification bearing S.O No.689 (E) published in the Gazette of India (Extraordinary) on 04.04.2011 issued by Deputy Secretary of Ministry of Road Transport and Highways ,Government of India purported to be under Section 2 of the National Highways Act 1956, may be furnished to me urgently.

A true photocopy copy of entire file containing all the notes/notings/orders/decisions of all the Officers/ authorities including notes/noting/order/decision/approval if any of the Minister for Road Transport and Highways ,Government of India relating to notifications regarding NH 208, and NH 17 purported to be issued under Section 2 (2) of the National Highways Act 1956, may be furnished to me urgently
