
Petition filed under Sec. 6 of the Right to Information Act

1. I am a permanent resident of Kollam in State of Kerala.
2. I am in need of information/document specified below in relation to the following:
 - a. NH 45, 220 were given new NH number 183 by notification dated 4th April 2011 by S.O No.689 (E) published in the Extraordinary Gazette on 4th April 2011. You are requested to inform me as to how and when the said NH 45 and 220 were included in the schedule to the National Highways Act and the S.O numbers and the dates of the notifications relating to the same. You are also requested to give a copy of the notifications if any said to be issued in relation to the said NH 45 and 220 under Section 2 (2) or (3) of the National Highways Act.
 - b. You are also requested to issue a true photocopy copy of entire file containing all the notes/notings/orders/decisions of all the Officers/ authorities including notes/noting/order/decision/approval if any of

the Minister for Road Transport and Highways ,Government of India relating to the notification bearing S.O 1126 (E) published in the Gazette of India (Extraordinary) on 07.04.2017 issued by Director (P and B) of Ministry of Road Transport and Highways ,Government of India purported to be under Sub Section (2) of Section 2 of the National Highways Act 1956 seeking an amendment of the entries relating to description of the highways shown as serial Nos 219 and 267 in the schedule to the National Highways Act for the purpose of substituting a new description thereto.

3. I am in need of the said information urgently, in view of the urgency involved in the matter. Sec.7 of the Right to Information Act also mandates that the request under Sec.6 of the said Act shall be disposed of expeditiously. I am producing herewith the required fee as provided in Rule 4 of Right to Information (Regulation of Fee & Cost) Rules.

4. This may please be treated as top priority.


