R/sir,

At present the NA permissions, along National Highways are being given as per MORTH Circular no. NHIII/P/72/76 dated 13 January 1977

As per this circular, building line is 40m from center of road on either side of National Highways. However vide above ref. letter, NHAI has requested to Chief Secretary of Maharashtra that a strip of 150 meter i.e. 75 meter from centerline of the National Highway on either side shall be notified as green belt and no construction activity except for development of national Highways/service road shall be permitted.

Being a policy matter you are requested to give suitable clarification regarding building line and control line distance to be followed in case of National Highways
