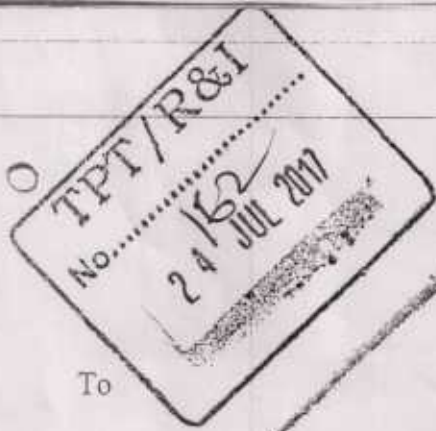



Dear Sir,

I Mohit Mittal resident of Delhi humbly request you to furnish me with the following information under section 6 & 7 of the RTI act:

Kindly provide the following information for traffic in Delhi:

- 1) Kindly provide me the details which authority or administration is responsible for providing guidelines for traffic management of Delhi.
- 2) Kindly provide me the details which authority or administration is responsible for providing guidelines for road construction of Delhi
- 3) Kindly provide me the details which authority or administration is responsible for managing the traffic of Delhi.
- 4) Kindly provide me the details which authority or administration is responsible for providing guidelines for traffic signals and signs.
- 5) Kindly provide me the details which authority or administration is responsible for providing gathering and analysing traffic data.
- 6) Kindly provide me following details about lane driving:
 - a) What are the traffic management guidelines and rules & regulations for lane driving.
 - b) What are the traffic violations associated with lane driving.
 - c) How many drivers were booked for violations from 1st Jan 2017 to 30th June 2017 for violations associated with lane driving.
- 7) Kindly provide me following details about lane guidelines for Delhi:
 - a) What are the guidelines for marking lanes on Delhi roads.
 - b) What is the prescribed minimum width for lanes to drive the vehicles at maximum permissible speed limit of 50 Km / hour speed.
 - c) What is the minimum radius of curvature prescribed for lanes on Delhi roads to handle the vehicles driving at 50 Km / hour speed.
 - d) Are all roads in Delhi, lane driving complaint and follows the above mentioned guidelines.
 - e) If answer to point 7d is No, What is the reason for that.
 - f) What are the traffic management guidelines and rules & regulations for changing lane while driving.
- 8) Kindly provide me following details about lane changing:
 - a) What are the traffic management guidelines and rules & regulations for lane changing.
 - b) What are the traffic violations associated with lane changing.
 - c) How many drivers were booked for violations from 1st Jan 2017 to 30th June 2017 for violations associated with lane changing.
 - d) Are all traffic police personal aware of these regulations.

- 9) Kindly provide me following analysis about traffic capacity (Number of Vehicles) of Delhi roads: PND
- a) Is current road infrastructure of Delhi suitable enough to handle current volume of vehicles.
 - b) If answer to point 9a is No, then what is the capacity of current infrastructure of Delhi, How many registered vehicles current infrastructure of Delhi can handle with smooth and uninterrupted movement of traffic.
 - c) How much traffic (number of vehicles per hour) a 2 lane road can handle, with smooth and uninterrupted movement of traffic without any traffic jam.
 - d) How much traffic (number of vehicles per hour) a 3 lane road can handle, with smooth and uninterrupted movement of traffic without any traffic jam.
- 10) Kindly provide me following data about accidents:
- a) What are the guidelines, procedure and steps followed to handle the accidents on roads which are small in nature and where both vehicles are in drivable condition after the accident.
 - b) What are the guidelines, procedure and steps followed to handle the accidents on roads which are big in nature and where vehicles are not in drivable condition after the accident.
 - c) Please provide list of accidents reported in Delhi in last three months and provide their analysis reports.
- 11) Kindly provide me following details about training and benefits reaped from them :
- a) List of all the persons who have taken any sort of long term or short term training regarding traffic management in any foreign country in last 5 years. Please provide their name, designation and period and dates of training.
 - b) Please provide list of suggestions those persons / employees have provided to improve the traffic conditions.
 - c) Please provide list of suggestions from 11b, that has been implemented.
- 12) Kindly provide me details of the basis of deciding the maximum permissible speed on any road. CRK
- 13) Kindly provide me details of current plan to improve the traffic conditions.
- 14) Kindly inform me in Yes/No format, is it possible to improve the traffic condition of Delhi and make the traffic congestion free at peak time?
- 15) If answer to point 14 is YES, what are the steps taken in that regard and what are the steps planned to be implemented in near future.
- 16) If answer to point 14 is YES, what is the timeline to complete the implementation.
- 17) Kindly provide me latest guidelines and rule book for drivers to follow while driving.
- 18) Kindly provide me latest road signs and signal booklet
- 19) Kindly provide me following details about traffic violations registered: RS-
- a) Total how many violators were booked from 1st Jan 2017 to 30th June 2017.
 - b) What were the top 10 category / type of violations booked and number of violators booked in each category.
 - c) Kindly provide vehicle wise (like four wheeler, two wheeler etc.) distribution of violators for each violation specified in reply of 19b.

The information requested does not fall within the restrictions contained in section 8 and 9 of RTI Act 2005. I request you to kindly furnish me with the requested information within 30 days.

If the above request or any of the information does not come under your department you are requested to send the application to the concerned department as per RTI Act 2005, of sec 6(3). And please inform me in written that it has been forwarded to the concerned department in case if the reply doesn't come under the define time frame of 30 days, I can appeal to that department for the RTI.
