

1. Details of Information:

It is brought to your kind notice that Your good office had issued Circular F.No.RW/NH-33044/117/2015/S,R&T(R) dated 23.04.2015 wherein it was clarified that the section of the National Highway which has been bypassed would cease to be part of the National highway. Thereafter, your good office had issued Notification dated 1st February, 2017 vide S.O. 318(E) amending the national highways in the Schedule of the Act stating that NH-48 starts from its junction with Rao Tula Ram Marg in Delhi at Km 14.3 of Old NH-8 connecting Bawal in the State of Haryana. Recently, your good office had issued Notification dated 23rd June, 2017 vide S.O. 1995(E) creating national highway near Shiv Murti on NH-48 connecting Bharthal Chowk, Delhi Haryana border in Delhi and terminating near Kherki Daula on NH 48 in Haryana.

- Q. No. 2. Whether the new National highway no. 248BB notified vide S.O. 1995(E) dated 23rd June, 2017 is notified to develop bypass of traffic on the existing NH48 stretch from Shiv Murti to Kherki Daula?
