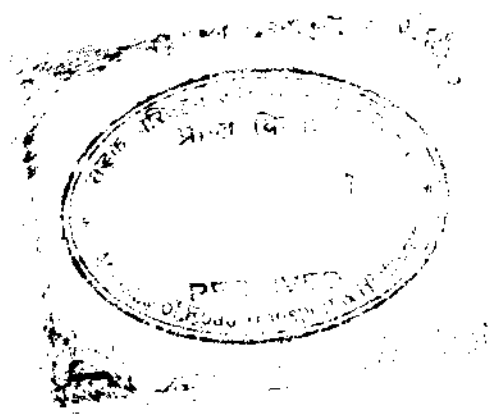

Sir,

Please refer to the enclosed copy of Ministry of Road Transport and Highways' letter No. A-32013-03/2009-E.II(Pt.) dated 21.07.2016. In this letter, it has been mentioned that "so far the ACR for the period 10/2003 to 03/2004 is concerned, it is informed that initially the ACR contains adverse remarks, however, the same were expunged with the approval of the then Hon'ble Minister as per the available records and the expunction of the adverse remarks could only have been done on the representation of the officer. Thereafter decision on not granting NFU have been taken on merit after due consideration of the grades achieved during the period."

2. In this matter, it is informed that I had never ever been communicated the adverse remarks as mentioned in para 1 above and therefore, being unaware of adverse remarks against me, there is no question of giving representation against any such adverse remarks which were never ever conveyed to me.

3. Even if it is assumed that any such representation had been made by me, then I want to know the following information from Ministry of Road transport and Highways as per the Application under RTI Act, 2005:

- (1) Please provide me the file No. in which the above representation has been processed.
- (2) The photo copies of the complete noting of the file as mentioned in para 3(1) above.

4. I am enclosing herewith Indian Postal Order of Rs. 20/-, as RTI Fees for obtaining information.
