

Sir/Madam,

Please provide certified copies of the following information/documents/notings, where the concerned authority for approval of funds is the Ministry of Road Transport & Highways, for construction of a bridge between the island of Chorao and Salvador Do Mundo under Bharat Mala in the state of Goa.

1. Information, notings and all documents of approvals for construction by the Ministry of Road Transport & Highways (MoRTH) and Goa Public Works Department.
2. Construction, survey and layout plans pertaining to Chorao, Tiswadi, Goa bridge hereinafter referred to as Chorao Bridge linking to Salvador-do-Mundo along with the approach roads on both sides of the bridge.
3. Environment Impact Assessment (EIA) Study/Report on Chorao Bridge.
4. No Objection Certificates/approvals received from Chorao and Salvador-do-Mundo Panchayats for the construction of this Bridge.
5. Approvals received from the Goa Coastal Zone Management Authority (GCZMA) for the construction of Chorao Bridge.
6. Approvals from the Forest department marking the number, height and girth of mangrove species to be felled as required for the bridge construction.
7. Commercial terms and cost break-up of the construction works and land acquisition and terms of agreement/MoU signed with the builder/contractor of the Chorao Bridge and Govt. agency name responsible for its execution/supervision.
8. Study conducted on the vehicular and other traffic movement between Chorao and neighbouring villages at present and the expected movement of traffic on the proposed Chorao Bridge.

In the event any of the above information sought is not available in your office, you are requested to forward this RTI application to the relevant Government agency.
