I own a organisation called DOVIEW HOLIDAYS INDIA PVT LTD -which deals with tourism products since 2013, we do provide the transportation to many tourist who comes to south india , I would like to know the RTO rules which they apply in southern states, for example we have received the guest request for providing a Tempo traveller ( 12 seated vehicle) for picking up the guest at Trivandrum airport, I own vehicles of Tamilnadu to enter Kerala I have to pay Entry permit from the RTO that all understood and we do get the permit but the check post people at Trivandrum demanding us to pay the Pick up charges which is INR 650 per seat which comes to 7800/- ( seven thousand Eight hundred only) I have tried to get in touch with the RTO in Trivandrum they are not even ready to answer any questions from the tour operators. May I request you to update on the same. If there is really a rule to pay taxes per seat basis we shall obey but the RTO trying to make money out of this .




