Text of RTI Application : The Excise department is aware that the consequent upon Hon'ble Supreme Court Order dated 15.12.2016 and 31.03.2017 Department of Excise, Entertainment & Luxury Tax, Govt. of Delhi did not renew the Excise Licences, L-15F/L-16 Licenses for the Licensing Year 2017-18 of various Hotels situated within the distance of 500 metres from the National/State Highway. Post these Hon'ble SC Orders, various State Governments have already taken and/or proposed positive steps to assist with the renewal of the Excise Licenses of the affected Hotels/Restaurants within their State and thus avoid significant losses to the both the private players as well as the Government. Furthermore, in the subsequent hearings/orders of the Hon'ble SC in July 2017 on the above mentioned subject, the Hon'ble SC not only did not restrict the State Governments from taking the steps referred above, but also confirmed that the States have complete authority to de-notify the highways within the city limits thereby removing the affected Hotels/Restaurants from the ambit of the above mentioned Liquor Ban Order. In light of the above, we wish to know the steps already taken/proposed by the Department of Excise, Entertainment & Luxury Tax, Govt. of Delhi for assisting with the renewal of the Excise Licenses of the affected Hotels/Restaurants in Delhi.
