#### Background

Defence personnel are entitled to toll tax exemption on all roads and bridges in India under the Indian Tolls (Army & Air Force) Act, 1901. The toll exemption is available on private vehicles too irrespective of the fact whether the concerned person is on duty or not. The said orders were passed by the Ministry of Road Transport and Highways

#### Particulars of information required

1. Please send a certified copy of supporting documents, rules and regulations/ orders or any government authority letter which supports the above mentioned subject
2. Does a retired defence personnel of India authorised for toll tax exemption? If yes please provide a authority letter.
3. Does a dependent of serving soldier and retired soldier authorised for toll tax exemption? If yes please provide a authority letter.
4. If any one who disobeys the orders pertaining to toll tax exemption and forcefully collect the money from defence personnel, what action should be taken by victims (defence personnel) and explain its procedure? What are the charges and punishment that should be faced by the offender ( toll gate employee)
