As per the Right to Information (Regulation of Fee and Cost) Rules 2005, prescribed by the Government of India, I request you to provide following information under Section 6(1) of RTI Act 2005. I have enclosed an application fee of Rs.10/- by way of Postal order.

I request you to furnish the following details:

- 1) Total number of road accidents in India
- 2) Total number of road accidents in India - State / UT wise
- 3) Total number of fatalities
- 4) Total number of fatalities - State / UT wise
- 5) Overall Economic loss due to road accident fatalities for the last 3 years
- 6) Overall Economic loss due to road accident fatalities for the last 3 years - State / UT wise
- 7) All India Road safety allocation for the past 3 years
- 8) All India Road safety allocation for the past 3 years - State / UT wise
- 9) Equipments that are used for measuring the visibility / retro reflectivity of sign boards and road markings
- 10) Equipments that are used for measuring the visibility / retro reflectivity of sign boards and road markings - State / UT wise
- 11) Whether measurement of markings & sign boards is made mandatory at accident prone black spots of state / UT.

Please provide the above information at the earliest possible time.

Also Please inform me the requisite fee for the preparation of captioned documents, if required, to enable me to remit the same in time by way of DD.
