

3. Inform for what kind of purposes, Parking Charges, Road Tax are being charged from the vehicle owners at the time of Registration.
4. Inform for what kinds of Usages, the Parking Charges, Road Tax can be utilized and for what kinds of Usages, these taxes cannot be used.
5. Inform in details regarding the difference between Toll Tax and Road Tax. Also inform about the prescribed Purposes and Usages which government can utilize these tax collections.
6. Send certified copies of prescribed Policies, Guidelines, Rules, Regulations related to Taxes, Fees, Cess, GST, Charges etc for recovering from the vehicles owners at the time of registration.

Send certified copies of all kinds of all Minutes of Meetings of Council of Ministers, Cabinet, Expenditure Finance Committee from 01-01-2015 to till the date/upto date you send the final information, regarding the charges of above said taxes/charges etc from a vehicle owners at the time of registration.
8. Inform how many total revenue was collected by your departments from each of Taxes/Fees/Charges/Levies/Cess etc from from 01-01-2015 to till the date/upto date you send the final information.
