Please refer to the letter no MCI-7(10)/2017-RTI/120256 dated 20th June 2017 wherein you have mentioned that it is necessary to get State medical council registration in every state of practice. Accordingly, I want to know following information regarding Registration of medical degree under RTI Act, 2005

1. As It is mandatory to get State Medical Council registration by each doctor in the state of their practice, is it checked for medical faculty in the medical colleges at the time of inspection of medical colleges for granting permission or recognition to the medical colleges.
2. Is State Medical Council registration of respective state is checked in the Declaration form submitted by each faculty and Assessment Form submitted by medical college.
3. As it is necessary to get State Medical Council registration of respective state, what action has been taken by MCI/SMC for implementation of the same.
4. Has any case been registered by MCI for not having respective state medical council registration in the declaration form submitted by the medical faculty. Kindly provide details of all such cases and what action has been taken against them.
5. Who is responsible for implementation of this Mandatory Registration? What is the Role of MCI in this regard?
6. Kindly provide a list of medical faculty who has been denied as faculty due to non-registration of doctor in the respective state medical council in the state of their practice.
7. Please provide copy of letter sent to any medical college regarding this mandatory provision of registration with each state. If not, then which authority is responsible for implementation of this mandatory provision, kindly provide, name and designation of Authority held accountable.
