
This is in reference to your Application filed online with the Department of Expenditure (DoE) which has been received in E.II(B) Branch on 06.09.2017 vide Regn No. DOEXP/R/2017/50769 dated 03/09/2017

2. It is informed that the E.II(B) Branch of DoE, inter-alia, deals with the subject matters of grant of certain allowances such as Transport Allowance (TPTA), House Rent Allowance (HRA), Dearness Allowance (DA), etc. to Central Government employees only. Hence, the specific information/clarification which has been sought in the Application is neither held nor available in any material form in E.II (B) Branch and cannot be furnished. It is also informed that your Application is being transferred to Ministry of Water Resources, New Delhi for furnishing information, if any.

3. It may be noted that it is well established in Law that as per the provisions of the RTI Act, 2005, the public authority can only provide information which already exists with the public authority or is held under his control. The Public Information Officer (PIO)/ Central Public Information Officer (CPIO) is not supposed to "create" or "interpret" information or to "solve" the problems raised by the applicants. The Act does not require the PIO/CPIO to deduce some "conclusion" from the "material held or provided" and supply the "conclusion" so deduced to the applicant. The CPIO is also not required to give his 'opinion' or 'advice' in any matter.
