BACKGROUND:

On 13th July 2017 HRDD government of Sikkim held counseling for MBBS seats, counseling was held for total 21 seats, 6 seats from central pool quota to the state of Sikkim, central pool quota had been anticipated and counseling was done six candidate who opted for central pool seat were asked by HRDD govt of Sikkim to wait for the seat arrive, but on 18th of August 2017 we got news from Ministry of health and social welfare govt of India through their website only 3 seats were allotted to the state of Sikkim, the seats were initially planned to be roster system.

In light of the above description, please provide me the following information:

1. Please inform me the reason for the amendment in the decision regarding allotment of only 3 seats to the state of Sikkim .

2. Please provide me the copy of the circular / letter in which it was decided for the allocation of only 3 MBBS seats to the Sikkim state.

3. Please inform me if the circular mentioned above was passed on to the concerned state department before or after 13th July 2017
