- 3) Details of PIO's reply: Response of the PIO is received vide his letter no. 9957(ID-1744/17)/ (D-I)/RTI Cell/SWD, Dated 17/07/2017, copy enclosed.
- 4) Last date for filing the appeal: 18/08/2017.
- 5) The grounds for appeal: As per the RTI Act, 2005, the Public Information Officer is supposed to provide the information which exists/is available with or under the control of the concerned Public Authority and without any interpretation or explanation therefor. Also the PIO cannot claim exemption from disclosure of the information except under any of the provisions of Section 8 and 9 of the aforesaid Act. However, it is not only that the PIO has not provided me the copy or the details of the document based on which the information, discussed below, have been furnished but has also denied the requested specific information in respect of my Application dated 22.06.2017 without offering valid/legitimate reasons for denial.

Specific grounds/reasons for this Appeal:

1: As S.I. V.B. Shinde, vide his letter no. 9166/P.S. Trombay, dated 29.12.2014, copy enclosed, requested for the copy of **the complete case file** relating to Complaint no. 69-N, the PIO may kindly be directed to provide me with the certified copy of the document based on which, the under-noted information is furnished by him:

- (i) That SI V.B. Shinde submitted his written request regarding getting some documents of the above said complaint.
- (ii) That he has requested that he is the IO of the said case and some documents of the above said complaint is the important part of investigation.

2: As informed by the PIO that after receiving the said request and getting approval of the Addl. DCP-II/SWD, SI V. B. Shinde inspected the above-said file and sought 20 documents. However, considering the fact that **Sh. Shinde, vide his above letter dated 29.12.2014, has clearly requested for copy of the complete case file**, I would request the Appellate Authority to please direct the PIO to provide me the following information and also the certified copy of the relative document(s),

- (i) That SI V.B.Shinde inspected the complete file of the above said case containing all 32 documents.
- (ii) That SI V.B.Shinde selected and sought 20 documents out of the 32 documents for his investigation.
- (iii) Who recommended and decided to allow SI V.B.Shinde to inspect the file and identify the documents to be provided to him?
- (iv) Certified copy of the document approved by the Addl. DCP-II/SWD to supply copy of the documents of the said Complaint.

In connection with this Appeal, I would also request the Appellate Authority to provide me the opportunity of Personal Hearing enabling me to submit few more extremely relevant points/factors in support of my Appeal, for his kind consideration.


