ORDER

Sh. V.P. Gupta (hereinafter called the Appellant), r/o C-11/9, Yamuna Vihar, Delhi-110053 has filed first appeal online on 31.07.17.

The RTI Application dated 29.06.17 of the appellant was received online wherein the appellant had sought the information on 10 points with regards to the increment/PPO of the retired police officers from January to May-2006, under RTI Act-2005. The RTI Application dated 29.06.17 was transferred by the Nodal officer/PHQ to all the PIOs of Delhi Police for providing the information directly to the appellant.

After obtaining the information from AC-III/Estt./PHQ (the principal supplier of the information), PIO/Estt., vide letter No. XXIV/29/Spl./ID-697/2017/ 3942/RTI/Estt./PHQ dated 27.07.17 had provided the available information to the appellant.

Being aggrieved, the appellant has filed first appeal and requested to provide complete information in respect of all units of Delhi Police regarding total number of PPOs revised of Delhi Police retirees as per OM dated 19.03.2006 and further stated that some units have not yet provided the information.

I have gone through the present appeal, RTI application, reply dated 27.07.17 furnished by PIO/Establishment, comments of AC-III/Estt./PHQ and found that PIO/Estt./PHQ had provided the available information to the appellant.

A copy of fresh reply dated 10.08.17 received from the principal supplier of the information is enclosed and a copy of first appeal is being sent to all the FFAs of Delhi Police for taking necessary action.

The reply provided by PIO/Estt., Delhi holds good. As such, the Appellate authority's intervention is not required in the matter.

The appellant may file second appeal against this order with Hon'ble Central Information Commission, within the stipulated period under RTI Act, 2005, if he so desires.

Therefore, the appeal is disposed off.
