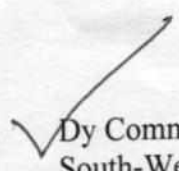

Sub: Ist Appeal against Non-Supply of Information/copy of records under RTI Act 2005.

Ref: Addl DCP/APIO---SWD letter No.11975(ID 2019 & Dy No.529/17)/(D-III) /SWD dated 17.8.2017

R/Sir,

1. Certain informations/copy of records was sought from the office of DCP- West- Rajouri Garden, New Delhi relating to complaint matter belonging to Police Station Uttam Nagar, New Delhi.
2. Since jurisdiction of Police Station Uttam Nagar, New Delhi, transferred now from the control of DCP- West- Rajouri Garden, New Delhi, to your good self i.e DCP-South West District, Sector-19, Dwarka, New Delhi, RTI application filed in the office of DCP-West, (Ref: ID No.2113/17/4361/DIC/West(DA-III) dated 19.07.2017 & endst (ID No. 2113/17/4713/DIC/West(DA-III) dated 07.08.2017) transferred/sent to you-DCP office, SW District accordingly for furnishing reply.
3. As such, Sh. Chandra Prakash Meena, Addl DCP & APIO of South West District, Sector-19, Dwarka, New Delhi, replied RTI application by letter No. 11975 (ID 2019 & Dy No.529/17)/(D-III) RTI Cell/SWD dated 17.8.2017 informing that "Complaints were marked to SI Vikas Sahu No.5038 for taking necessary action i.e. investigation/enquiry in the matter, but he had not deposited the above said complaints related papers in the record of PS Uttam Nagar, even after transferred from PS Uttam Nagar to PS Vikas Puri. As such requisite information could not be provided at this stage".
4. **By simple reading of facts depicted for non-providing informations revealed that same fabricated and untenable by person of ordinary prudence.** Sh Vikas Sahu, is acting simply as Sub Inspector (SI) No. **D-5038** (then SI of PS Uttam Nagar) & he could be contacted with "**Mobile No**" when he fled with case papers of matter from control of SHO of PS Uttam Nagar, New Delhi. (i.e. was not ready to deposit in record of PS Uttam Nagar even after getting transfer of PS Uttam Nagar), therefore please furnish complete address of Sh Vikas Sahu, Sub Inspector (SI) No. **D-5038** (then SI of PS Uttam Nagar) with Mobile No so that appropriate action be taken now.
Further kindly furnish complete "Name & address of controlling authority" & "**Vigilance Authority in Delhi Police**" of Sh Vikas Sahu, Sub Inspector (SI) No. **D-5038** (then SI of PS Uttam Nagar) who, were responsible for not obtaining complaint papers and helped in relieving/fleding from PS Uttam Nagar, New Delhi, without effecting proper handing-taking over.
5. In views of facts and circumstances referred above may I request your kind honour being **Appellate Authority under RTI Act-2005 & Incharge of SW District** looking to seriousness of matter, kindly exercise your kind controlling power by **directing** Sh Vikas Sahu, (SI) No. **D-5038** (then SI of PS Uttam Nagar) over phone/ letter /through SHO concerned to immediately deposit subject matter complaints paper in record of PS Uttam Nagar immediately & applicant be provided information accordingly.
