Dear Sir,

1. The undersigned has received a reply from the Addl. Dy Commissioner of Police (I) Cum PIO, North West Distt., Ashok Vihar, Delhi-110052, vide (DEPOL/R-2017/19316) ID No. 2403/17/6076/RTI Cell/NWD dated, Delhi, the 23/08/2017, in reply to my application dt 27.07.2017 under RTI Act-2005. Sir, I have prepared the above application dt. 27.07.2017 (Encl. ~~1~~) on the above subject factual problems being faced by the undersigned for the past several years, to ameliorate my sufferings from the police station Model Town, Delhi. But, the investigation officer so appointed is reluctant/lethargic and would

submit his inquiry report to the SHO, Model Town, Delhi-9 with some ulterior motives of have connived with the alleged person Gurjeet Singh/his family members, and never verified the facts, stated to have been submitted by the undersigned. Hence my every reply on the alleged false complaint either made in writing or complaint of PCR having not any truth by the complainant Gurjeet Singh or his family members. Sir, I replied vehemently to all the false complaints reported to me. Sir, in this regard it is stated that when any complaint is received against the undersigned on "seepage of water from 4' wide gallery" of the undersigned, submitted by the alleged Gurjeet Singh/his family members. Even request to the IO to supply a **copy of alleged complainant, the copy of complainant's complaint, has never been provided to the undersigned** by the IO. Sir, this is abrogating the Right of Information to the undersigned for the past several years. Whenever I replied to several complaint either made in writing/PCR call pertaining to the complainant against the undersigned.

2. Sir, my above complaint dt. 27.07.2017 to the Addl. Dy Commissioner of Police (I), replied by the said officer vide his above ref. reply Dt. 23.08.2017, is unsatisfactory. Sir, nowhere in my application under RTI Act-2005, from paras 1 to 6, I have never required information in the form of question like how, whether, what and why in my above RTI Act-2005 application dated 27.07.2017. Hence, the reply of Addl. Commissioner of Police (I) Dt. 23.08.2017 is again being submitted to the Ist appellate authority-cum DCP, to reconsider and replied to the undersigned application dt. 27.07.2017 (Encl.) from Sh. No. 1 to 6.

3. Sir, all the relevant enclosures to the application dt 27.07.2017 have been submitted by the undersigned to give relevant reply by the IO/ASI Rajesh Kumar to reply my points 1 to 6 parawise.


