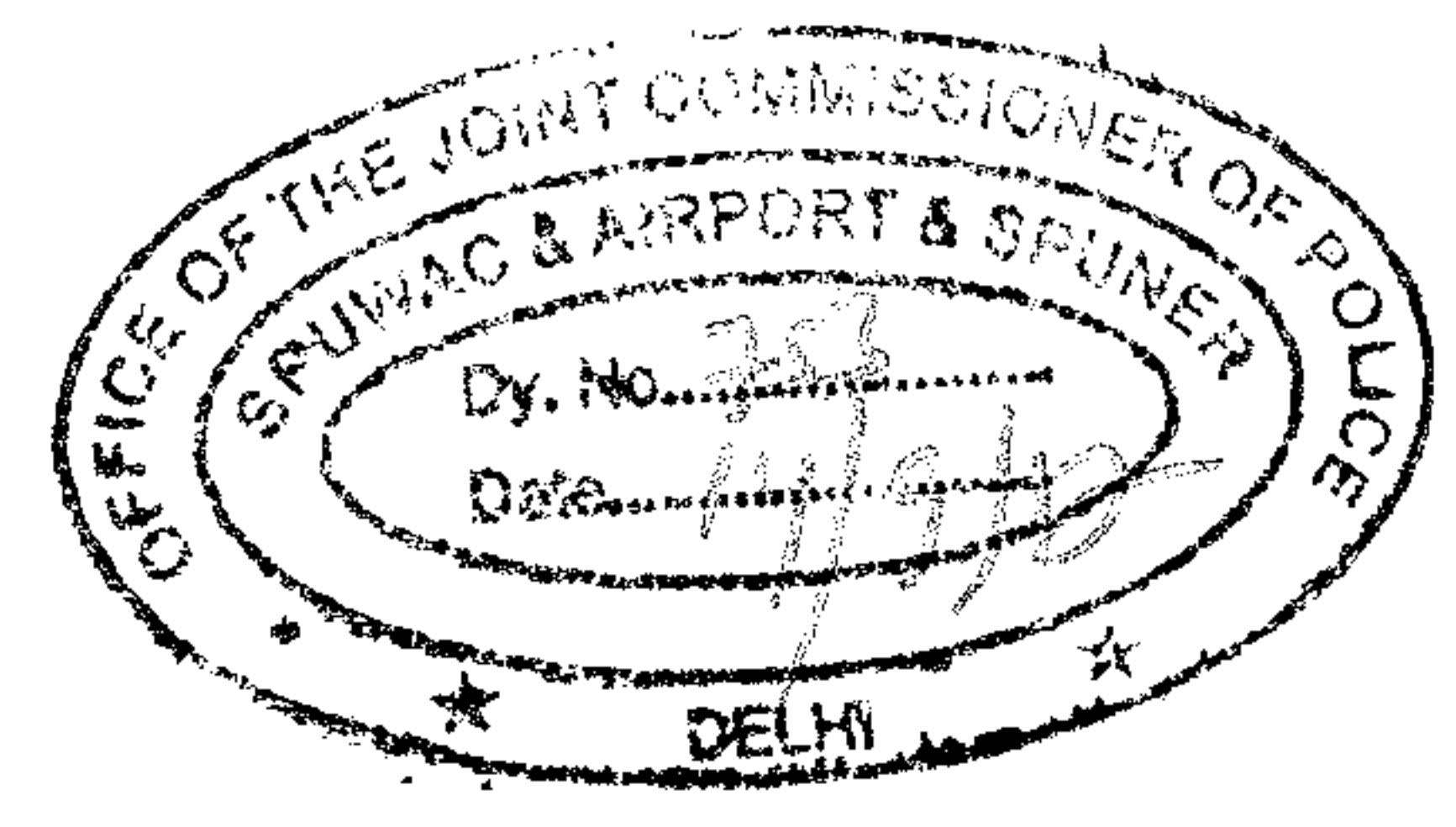

And further prayed to pass necessary directions to the Officer-in-charge of Complaint Branch and Officer-in-charge of RTI Branch of SPUWAR to keep the records of complaints and its investigation Reports by CAW cell authority of N/W and Handi Para authorities as described in para-3 till the completion of trial or appeal by the courts concerned.
