4. Certified copied of Bail Orders in respect of all 5 suspected persons viz. (1) Shri Ved Prakash Shastry (Father-in-law) (2) Smt. Pushpa (Mother-in-law), (3) Smt. Rekha Sharma (Sister-in-law), (4) Shri Dheeraj (Brother-in-law) and (5) Shri Neeraj (Husband).
