Respected First Appellate Authority had allowed information from DCP NWD office and directed undersigned to give reference number , so that records were shown and copies given.(Undersigned request was received by PIO/DCP office diary number 2758 DATED 25/08/2017).

Now , I had received a letter No ID 2758&2979/17/9363/RTI CELL/NWD/dated 22/9/2017 from LD CPIO (which has enclosed junior staff of I/C VRK, Sub Div stating that undersigned is accused and his case is pending in Rohini Court) , hence information of case diary can not be provided.

I am still waiting for inspection and copies.

kindly direct concerned officers in Shalimar Bagh to give copy of all records , before they were tempered by the staff.

None of record is exempt from RTI disclosure as per Delhi High Court decision in W.P.(C) 12428/2009 & CM APPL 12874/2009 Deputy Commissioner Of Police vs D.K. Sharma on 15 December, 2010 by Hon'ble JUSTICE Mr. S. MURALIDHAR. In the above case , Case diary copies are allowed .

And I also wants inspection of Original as well Carbon copy documents / register of same(which not shown on last inspection).

Kindly provide copy of same, free of cost as per RTI Act, 2005.

It is gross indisciplin by field staff to overrule orders of Central Information Commissioner, First Appellate Authority Dy
