This is further to my application dated 03.08.2017 filed with Public Information Officer, Delhi Police (North-West) under RTI Act 2005 (Copy enclosed) Since the reply submitted by PIO, Delhi Police (N/W) Ashok Vihar, Delhi vide their ID No. 2512/17/8093/RTI-Cell/NWD dated 01.09.17 (copy enclosed) in reply to my aforesaid application dated 03.08.17 is vague and incomplete, I submit my appeal to your goodself as Appellate Authority requesting you to get me the reply on the following questions.

Documents/Details Required

1. Please furnish the documents indicating the progress and action taken report to its final conclusion on my complaint dt. 17.04.2017 to S.H.O, Mourya Enclave Police Station, Pitampura and further reminders addressed to DCP (N/W) Ashok Vihar on 15.06.2017 and 28.06.2017.
2. The copy and details of FIR filed against the accused on the basis of my aforesaid complaint and action taken report to its final conclusion on the same.
3. Name and Designation of the official who have been assigned to take action on aforesaid FIR as well as complaint and documents indicating the reasons for not taking any action or keeping it pending.
4. Please provide action taken report on the complaint dated 17.04.17 by S.H.O. Mourya Enclave as directed by ADDL. DCP (N/W) marked on 16.06.17 to him.

Reasons for Appeal

I am informed that they have forwarded the said complaints to PIO Delhi Police Rohini, District Delhi inspite of the fact that Sh.
