Subject : Complaint against payment not given by the vendor after using of vehicle for transportation of staff of Tech Mahindra, Noida.

Respected Sir,

I Mrs. Nirupama Nag W/o Ram Mohan Nag R/o H-101, Sri Niwas Puri, New Delhi – 110065 having owner of the vehicle no DL1RTB9673 and this vehicle was used by G G Tour Travels, Jasola Vihar (Owner Gaurav Garg Mob 9953170509 Accountant Santosh Mob 8882188243, 9582260431) for transportation of the staff of Tech Mahindra, Noida from Mar 2017 to 10 June 2017. In this regard this vendor was assure for payment monthly after completion of one-month period. I was received a payment amount 15628.00 for the month of March 2017 from this vendor. Billing for the month of April 2017 was 27000.00 and this payment was given by the concern agency on 05/07/2017 with partly payment of two cheques i.e (1) 10000.00 was pay with dated of 05/07/2017 (2) 17000.00 was paid with written dated of 10/08/2017. Payment of 10000.00 was bounce due to unavailable fund. I was resubmitting this cheque and it was cleared on 17/07/2017.

Till this date I am not received payment for the month May 2017 for roaster of 91 and up to 10 June 2017. This organization not paid the 7 roaster of March 2017, 8 roaster of April 2017. Concern person of this organization was assuring for payment of pending roaster after approval of Sub Vendor Mr. Pawan. Sub Vendor is also terminate from service from 25 May 2017.

But till this date no payment given by the concern authority. My husband follows up this organization from 5/06/2017 but concern organization is ignoring our request. Not paying the payments of pending roasters of March 2017 for 7 roasters, April 2017 for 8 roasters and pending payment for 91 roasters for May 2017 and up to payment of 10 June 2017. This organization had restricted my vehicle due to Driver negligency. This organization having impose penalty against my vehicle for amount of 5000.00 which is illegal. Both parties not sign any agreement for imposing this type of penalty.

Therefore requested to the concern authority please resolve my complaint as desire. I was already have submit this matter to your organization through RTI vide RTI application no DEPOL/R/2017/51888 dated 18 July 2017. I was submit my two written application on dated 24/07/2017 to the RTI Cell, Room No 213, Office of the Deputy Commissioner, South East District, Sarita Vihar.

Therefore I humbly request to the concern authority please interfere in my case and resolve this case as soon as possible. Because I need fund urgently due to upcoming medical treatment of my mother in laws and for my self also which I was earlier mentioned in my RTI application.
