**1.** Provide number of challans issued (till date) against Vehicle having Registration Number: **DL8CAW-0517** registered on name of the under mentioned applicant, i.e, Vikas Bhaskar.

**1.a** Provide details of challan(s) issued on 24.09.2017, if any, against Vehicle having Registration Number: **DL8CAW-0517** registered on name of the under mentioned applicant, i.e, Vikas Bhaskar.

**(NOTE:** The information requested in the RTI Application is requested by the applicant, who is also the owner of the above stated vehicle and hence, no 3<sup>rd</sup> party information is requested, as the information is requested for self owned vehicle, copy of Crossed RC attached for reference)

**2.** Provide name of Delhi Traffic Police Officials on duty on 24.09.2017 at Red Light/Traffic Signal located at Vikas Marg (Right turn from road coming from Old ITO Bridge to Indraprastha Marg going towards IG Stadium)

**NOTE:**

1. If you feel that above requested information does not pertain to your department then please follow the provisions of Section 6(3) of the RTI Act, 2005.
2. Please refer to Office Memorandum issued by DoPT dated 08.01.2014 states, in light of Writ Petition No:33290 in the case of Mr. Avishek Goenka vs. Union of India, whereby the said O.M states that "we have considered the relevant provisions of the statute. Section 6 /(2) of the RTI Act, 2005 would clearly provide, an applicant making request for information shall not be required to give any reason for requesting the information or any other personal details except those that may be necessary for contacting him...."

"...the Secretary, Ministry of Personnel should circulate the copy of this order to all concerned so that the authority can take appropriate measure to hide information with regard to personal details of the activist to avoid any harassment by the person having vested interested."

4. Refer DOPT O.M. No. 10/1/2013-IR dated 6.10.2015 regarding 'certified copies'
5. Refer to decision of F. No. CIC/AT/C/2006/00069 dated 31.01.2017, appellant is allowed to use advanced camera technologies by using his own resources to copy these documents.
6. Refer to decision No. CIC/SG/A/2009/00601/3306, Assistance of another person for the inspection is allowed. I may also bring an Advocate/Chartered Accountant/Social Activist/Other to assist me during Inspection.
7. Refer to directives laid down by the **Delhi High Court in its judgment** dated **16.12.2014, Adesh Kumar vs Union of India** wherein it has been categorically stated that :  
*"RTI can be used even if information not relevant or germane and **even if applicant has access to material through other means**".* Para 11 of the said judgment be referred for further clarification.
8. Refer to Section 166, IPC 1860-Public Servant disobeying law....
