Subject: Theft at my house A/C-1, First Floor, Tagore Garden, New Delhi - 110027 by my Daughter in Law viz Mrs. Priya Matharoo, her father Mr. Vachitar Singh Matharoo R/o House #931, Model Colony, Yamunanagar, Haryana, her brother Mr. Tejinder Singh Matharoo and his wife Mrs. Gurinder Kaur r/o Vasant Kunj, New Delhi in our absence

Most Respectfully, I want to bring the following facts into your kind notice for necessary immediate action:

1. That my son got married on 12/3/2016 to Priya Matharoo, D/o Mr. Vachitar Singh Matharoo. After 4 months of the marriage, myself and my wife went abroad to stay with our daughter for 6 months. My son used to go to his day job as part of his daily routine. Mrs. Priya Matharoo had the access to all the keys of the home. We found out that in our absence, Mr. Vachitar Singh Matharoo (Father), Mr. Tejinder Singh Matharoo (Brother) and Mrs. Gurinder Kaur Matharoo (Sister in law) made several unannounced visits to our house. Also, during this period, Priya Matharoo's visits to her parental home in Yamunanagar increased drastically (10-15 visits in 2016).

2. Soon after we came back to India, Mrs. Priya Matharoo left her matrimonial home i.e. A/C-1, First Floor, Tagore Garden, New Delhi 110027 for her parental house on 26/3/2017 afternoon citing to attend the bhog ceremony of her Uncle (cousin Maasad ji) on 27/3/2017 and that she would return within 3-4 days. When my son called her up to come back, she said that "I have taken the things I wanted to take and now there's no reason to come back to my matrimonial home."

3. Alarmed by her statement, we immediately decided to check our valuables kept at home and found out that Mrs. Priya Matharoo has taken away our gold and diamond jewelry worth Rs. 4.5 Lacs approx. without our knowledge and consent which is THEFT under IPC Section 380. It is pertinent to mention here that the aforesaid articles belong to us and have been duly acquired over a period of time and she has no right over the same.

4. That I have every reason to believe that Mrs. Priya Matharoo hatched a conspiracy with her father, brother and sister-in-law to steal the belongings from her matrimonial home and once she had what she wanted, started refusing to come back.
