a) Subject matter of the information : The applicant is the husband of deceased Disha Koundal d/o Sh. Ajit Singh, resident of Vill. Birta PO Ghurkari Tehsil and District Kangra HP. The marriage of applicant and Disha Koundal has solemnized on 10-2-2015. The deceased Disha Koundal was doing her job in the Golden Jaipur Hospital at Delhi and during her service at the said place she has tried to commit suicide on 22-10-2016 and has expired on 23-10-2016 at the said place and on that basis the FIR has also been registered in the Police Station Ranibagh New Delhi. It is pertinent to mention here that after few days of solemnization of the marriage the deceased Disha Koundal has left the society of the applicant with out any rhyme and reason and has started living separately at New Delhi. On July 2016 the applicant has filed a divorce petition titled as Aneesh Nanda Vs. Disha Koundal in the court of District & Session Judge Kangra at Dharamsala.
