Sub: Seeking further information under RTI Act 2005 against the reply of DCP, PCR dated 27.06.2017 on RTI application dated 24.05.2017 regarding anomalies occurred in fixation of pay of ASI Rakesh Kumar, No. 275/PCR (PIS No. 28981284).

Respected Sir,

Please refer to reply received from DCP, PCR vide letter No. ID-2481/2017/10985/RTI Cell (AC-I)/PCR dated 27.06.2017 (copy enclosed as **Annexure-A**) with reference to the applicant RTI application dated 24.05.2017 (copy enclosed as **Annexure-B**) seeking information under RTI Act, 2005 regarding anomalies/discrimination occurred in fixation of my Pay. Sir on going through the reply furnished by the Office of DCP/PCR on 27.06.2017, it is observed that there are some point mainly relating to fixation of pay are not clear and mislead the factual position. In order to aware factual position on points raised by me, I again requested to furnish the following information under RTI Act which are necessary for me as I am facing a huge financial loss due to wrongly fixation of my pay after granted MACP to me on 22.05.2016.

(i) In reply to point no. 5(i) & (ii), it was replied that on 22.05.2016 the pay of the applicant had been fixed on option. Wherin I would like to say that no option in this regard have been given by me. However, a copy of option dated 12.12.2016 vide Dy. no. 2811 dated 13.12.2016 (copy at **Annexure-C**) and further on 23.12.2016 vide Dy. No. 2921/1/PCR dated 23.12.2016 clearly exercises by me that my pay may be fixed w.e.f. 01.07.2016 after granting annual increment due on 01.07.2016. Thus, it is requested that a copy of my option opting fixation of my pay w.e.f. 22.05.2016 on MACP may please be furnished.

4. Sir, the information whether the pay fixed in respect of above official of Delhi Police are found to be in Order in your opinion. If the same is in order the reason why should be applicant deprived of granting increment in line with the above officials on the plea of revised pay fixation Rule, 2016, besides the option submitted by the applicant to fix his pay on MACP after granting Annual increment to him on 01.07.2017. This information/clarification may please be furnished alongwith the reason for wrongly implicated revised pay fixation Rule, 2016 in my case.

5. Sir, the above information is help me to put up the matter before the competent Authority/senior Officers and court of law which enable me to grant justice as the applicant is suffering financial loss in term of not granting Annual increment as per procedure.

6. I am enclosing a Postal Order of Rs. 10/- bearing No. 389 242357 dated 24/7/17.
