Sub - Complaint about not taking the needful  
action by police.

Respected Sir,

I Shreejit Singh W/o Jitender Singh  
R/o R2 2/286 Street No. 3, Cretanjali Park, Bagaspur  
West, N.D. - 110046 want to make a formal complaint  
on the above subjected issue. The fact related to  
the complaint is as follows :-

- 1- I have made a complaint against Vikas Chaudhary  
regarding conspiracy to burn me alive (I had  
shown that clip to police station), Criminal breach  
of trust and forging of public document by  
D.D. No - 47B Dated 21/05/2016. When I asked  
to police they said they will investigate the  
matter first. then they will be able to  
take any action But my complaint was  
neither investigated nor any action initiated.
- 2- Next day Date 22/05/2016 I have made an  
F.I.R 291/16 against Vikas Chaudhary and  
his wife Aasha Chaudhary regarding hitting  
and threatening me (Vikas Chaudhary hit me  
on my face and <sup>bit</sup> my teeth) and said that  
he will set me in Prostitution.

3. No action was taken by the police so a formal complaint was made to A.C.P and the same to D.C.P. Sect West Delhi by hand on 25/05/2016

4. On the same date 25/05/2016 my mother in law made a complaint D.D.No. 52B. against Aasha Chaudhary. Where she warned to my mother in law that "tumhari Bahu ne jo vikas ke khilaf FIR karai hai usse hapas le lo nahin to main tumhare bete ko rape aur marpedt ke आरोप me farsa denge!"

5. In inspite of religious follow up when no action was taken then a complaint was sent to Joint Commissioner of Police on dated 20/06/2016

6. I was forced by police to leave my residence due to not taking any action by police. I left my residence and me and my husband compelled to live with my mother at her residence.

7. Even after being shifted to my mother's home vikas chaudhary used to follow me at my new place even whenever I go he follow me with his friend Ajay Kumar. When I was going towards market he hold my hand and said "Saali Raud tuun Aur ~~tere~~ tere Bhadwe ko wo maal karunge yaad Rakhegi" I have made the complaint regarding the same on dated



- I asked police to giving me update about my complaints they said "Hum Aapko jawab nahi denge jawab Jahan bhajne the bhaj diya."
- 9- No action initiated then dated 05/09/16 I went with my complaints to meet Respected Addl. D.C.P Mr. Rajesh Dew After looking my complaints He directed thana Sagarpur S.H.O to make chargesheet against the accused.
- 10- After few days I went police station to get update. Police did not made chargesheet Even After direction of Addl. D.C.P. when I asked they said "We are investigating the matter."
- 11- No action initiated then Dated 25/11/16 I went to meet Respected D.C.P Suresh Kumar Sir. He assured me that He will look into the matter then he will take the legal action.
- 12- After 3-4 days I received a call from CAW ACP Madam OMWATI MALIK. I went Dwarka Sec 9 to meet her she look my F.I.R and said "Police ne isme bhi se charegen nahi lagai hain isme 354B(b) Taidani"

13- Police did not added 354 B.

14- Dated 27/01/2017. I went to meet Adlde  
DC-P Deotosh Kumar with my all complaints  
He assured me that nikas will not  
harm me and he will look into the  
matter.

15- No action initiated ~~to~~ then Dated 27/01/17  
I went to meet Respected Jt.-P Dependur  
Pathak Sir with all my complaints  
After listening me. He directed AC-P

to add Section 354B and to make  
the chargesheet against the accused 11/17/17

16- After directions of Jt.-P Dependur  
Pathak Police made the chargesheet  
But they did not added the section  
354B After the many directions of  
Higher Authorities

On the basis of above facts and circumst-  
ances. I would request you to please  
take the legal Action against the guilty  
officers and I request you to set me  
and my husband to my own home.
