1. I went to Kirti Nagar Police Station on 27/07/2017 to register a police complaint but my complaint was not registered by police officials and they insisted not to register my complaint and assured that strict action will be taken against the accused without registration of complaint. Copy of complaint was also given to Beat Officer Manoj of Kirti Nagar Police Station. And now I have got to know that after my complaint, in order to counterclaim my complaint another complaint was registered against my husband by Dwarka Nath on 29/07/2017 for which I want a copy of the complaint registered by Dwarka Nath on 29/07/2017 as early as possible.

2. That I registered a complaint in Kirti Nagar Police Station vide DD no. 19A on 01/08/2017 for which I want a copy of the complaint I registered on 01/08/2017 containing three extra handwritten pages in contrast to 27/07/2017 complaint given to Beat Officer Manoj.

3. That I visited three times Kirti Nagar Police Station

a) On 27/07/2017 I went to Kirti Nagar Police Station between 5pm to 8pm but my complaint was not registered.
