

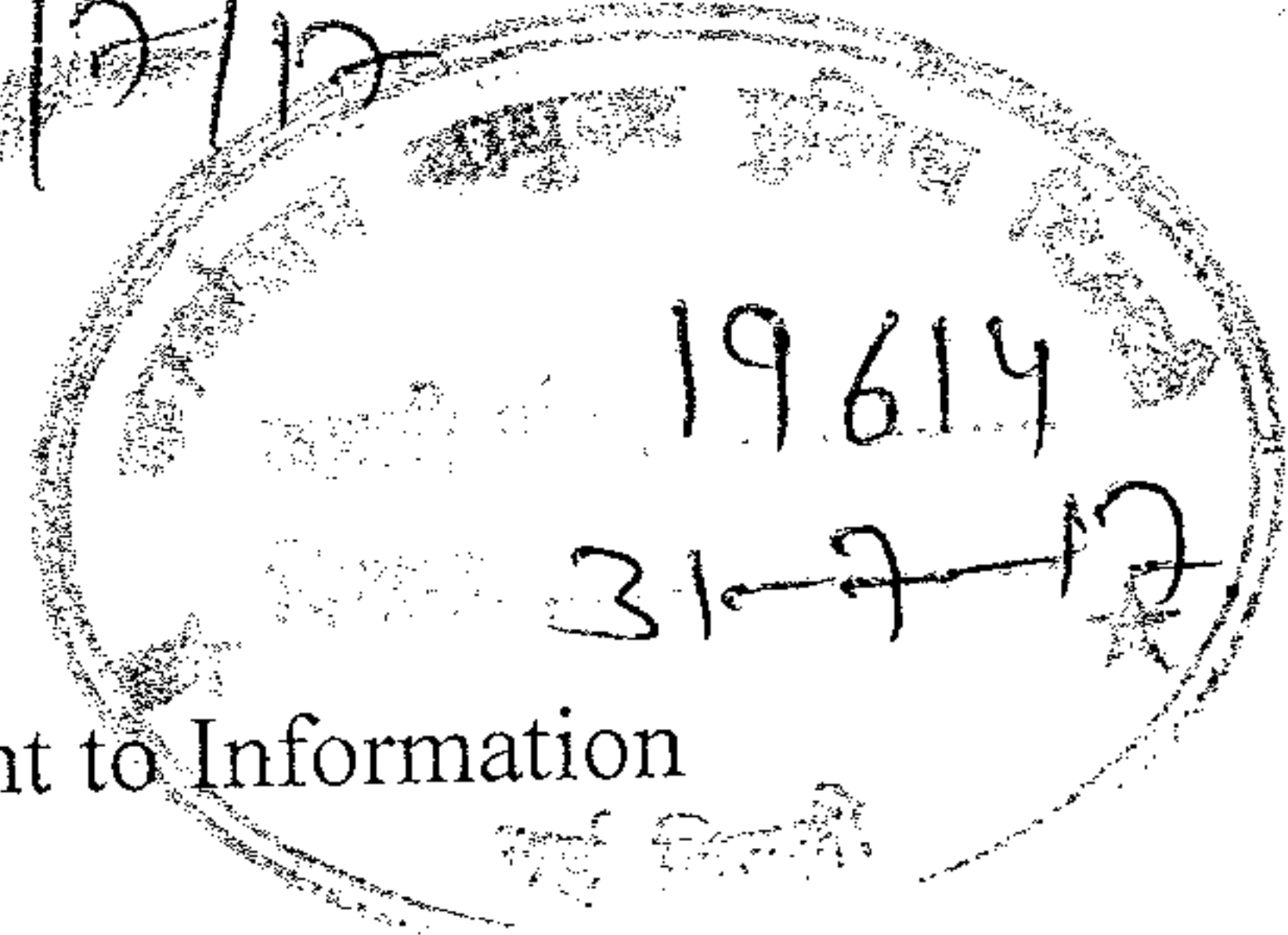

Subject:- Request to provide information; as per the provisions of Right to Information Act, 2005.

Sir,

Kindly provide the following information as per the provisions of R.T.I Act, 2005 (I am enclosing copy of Criminal Law Amendment Act, 2013 as ready reference and seek information in this regard).

- 1)- Is this amendment applicable in the state of Delhi?
- 2)- Is it mandatory for an S.H.O of any Police Station to register an F.I.R for Crime Against Women as specified in Section 166-A (Copy enclosed).
- 3)- Is it true that the S.HO is bound to register an F.I.R within 24 hours from the date of receipt of any such Complaint?
- 4)- What action is taken against an erring S.H.O in this regard? 9231
- 5)- Is the S.H.O dealt legally? (Criminal action is taken) 01/08/12
- 6)- Is the S.H.O dealt with departmently? (Departmental Inquiry is ordered/ conducted).
- 7)- If a complaint of above nature is got received in Police Station and after a week the S.H.O is informed in writing regarding this amendment then also if the S.H.O knowingly and willingly does not register an F.I.R. What action would be taken in the state of Delhi against such S.H.O?
- 8)- What action would be taken against the I.O/E.O/S.H.O if such complaint discloses offences as quoted supra with regard to a 12 years old minor girl.
- 9)- What is the role of discretionary powers of Police Officer in this regard. Can the S.H.O violate the law considering his discretionary power.
- 10)- Can the S.H.O keep the complaint pending enquiry without registering an F.I.R.
- 11)- Can the S.H.O mark such complaint to any male police officer? (where 12 years minor girls involve/ victim).
- 12)- What are the guidelines issued by the Hon'ble Supreme Court of India in this regard? (regarding enquiry/ investigation of Crime Against Women).

13)- Please provide the attested copy of such guidelines as quoted supra in crime against woman as in Q no.12.

14)- What are the guidelines issued by the Hon'ble Supreme Court of India in this regard? (regarding enquiry/ investigation of crime against minor girls).

15)- Please provide the attested copy of such guidelines as quoted supra in crime against minor girls as in Q no. 14.

16)- Is there any circular/ standing order/ guidelines issued by the Commissioner of Police, Delhi or on his behalf in this regard? (regarding crime against woman enquiry/ investigation of Complaints/ F.I.R).

17)- Please provide the attested copy of such circular/ standing order/ guidelines as quoted supra in crime against woman as in Q no.16.

18)- Is there any circular/ standing order/ guidelines issued by the Commissioner of Police, Delhi or on his behalf in this regard? (regarding crime against minor girls enquiry/ investigation of Complaints/ F.I.R).

19)- Please provide the attested copy of such circular/ standing order/ guidelines as quoted supra in crime against minor girls as in Q no.18.

20)- Any other information found relevant/ deemed fit.
