With due respect it is stated that the applicant is a citizen of India and now is residing at H. No. 10-B/74, Sec. 10, Vasundhra Ghaziabad U.P. with his family.

The applicant is the son of Late Sh. Ram Nath. His father was appointed as a constable in Delhi police on 26.09.1962 and later on he was promoted as Head Constable and then as assistant Sub-Inspector, **who has been expired on 04.09.2016.**

On 09.09.1994 when father of the applicant was posted in PCR than a departmental enquiry was instituted against ASI Ram Nath on a false complaint by the order of the DCP, PCR and since then his father was contesting the said matter before his department, the Hon'ble CAT at Delhi and lastly in the Hon'ble High Court of Delhi which is still pending.

The applicant came to know that his father ASI Ram Nath was transferred from PCR to the office of Dy. Commissioner of police, Security New Delhi **as per PHQ order no. 45221-34/CB-II/PHQ dated 09.12.1994** and relived on 20.12.1994 and he was paid up to 31.01.1995.

That since Feb. 2017 the applicant is continuously approaching personally and through the applications to the department of his father to know & get the **DUES/FUNDS/GPF ETC. OF ASI RAM NATH EX. NO. 293-D (PIS NO. 28620144)** which has not been received due to said litigation. But till date no any response has been given to him.


