1. As mentioned above applicant presently lodged in Central Jail, Tihar vide FIR No. 39/2015, P.S. Nihal Vihar. Kindly provide the information that how many locations of scenes of crime was inspected by S.I. Devender Singh, D- 4285 I/C West District Crime Team, P.S. Janak Puri, Delhi in the FIR No. 39/2015 of P.S. Nihal Vihar i.e. location description of scene of crime, date and time of inspection etc.
2. Kindly provide the information that how many persons/officials visited the scene of crime in the FIR No. 39/2015 along with S.I. Devender Singh, D- 4285 I/C West District Crime Team, P.S. Janak Puri, Delhi. Kindly provide the name and designation of the officials.
3. Kindly provide the information that what investigation has been made during the visit to the scene of crime and what evidence/material is tried to locate from the scene of crime.
4. Kindly provide/supply the information that what exhibits was collected and seized during the inspection of scene of crime in the FIR No. 39/2015 inspected by S.I. Devender Singh, D- 4285 I/C West District Crime Team, P.S. Janak Puri, Delhi. Kindly provide the detail description of the exhibits.
5. Kindly provide/supply the information that after collecting the exhibits from the scene of crime to whom and when (name of the official, date & time) it handed over in concerned police station i.e. P.S Nihal Vihar by S.I. Devender Singh, D- 4285 I/C West District Crime Team, P.S. Janak Puri,

Delhi.

6. Kindly provide/supply the information that after the collecting exhibits from the scene of crime it was handed over to the concerned police official in sealed or unsealed condition.
7. Kindly provide the information that how information had been receive for inspection of scene of crime to West District Crime Team. **Either** it was received through Wireless message, kindly provide the entry of said wireless message **Or** if it through written request by concerned police station, kindly provide the copy of written request for inspection of scene of crime.


It is, therefore requested that aforesaid information is directly relates to the applicant. Hence, information may kindly be furnished/provided to the applicant at the earliest.
