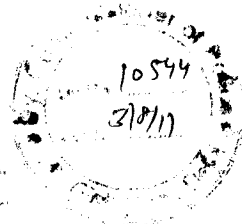

So far as this Court is concerned, as per the search made through the available computer software, No cases under section 124A of the Indian Penal Code were found for the year 2006-2007. A total of 25 cases were filed under section 124A of the IPC from the year 2008 onwards which includes 1 Bail Application, 4 Criminal Appeals, 6 Criminal Misc. Cases, 1 Death Sentence Reference and 13 Writ Petition (Criminal).
2.	I would also like to know how many FIRs have been registered, how many chargesheets have been filed, number of persons convicted and number of persons convicted under sedition across India from 2006 to 2017.	The information sought for pertains to the PIO, O/o, Addl. Deputy Commissioner of Police, Delhi Police Head Quarters, Establishment, 2 nd Floor, MSO Building, I.P. Estate, New Delhi-110002. Therefore, a copy of your application is being transferred to the said public authority.


