Subject: - Provide information under Right to Information Act 2005

Respected Sir/Madam

My husband Mr. Amit Aggarwal filed complaint against me at Model Town Police Station Police, New Delhi - 110009.

The complaint comes under your office. Hence I kindly request you to provide the below mentioned information under the 'Right to Information Act 2005 - under Section 6(5), 6(1) (a) or 6(1) (b) & 7(1) and 2(j)

- (1) Provide me the copy of the complaint filed against me (Rashmi Aggarwal) by my husband Mr. Amit Aggarwal r/o House no. F - 7/6, Model Town, Part - 2, Delhi - 110009 from 22<sup>nd</sup> November 2016 to 13th December 2016
- (2) Had the Complainant submitted any documents/audio or video recording in support of his complaint?  
Yes/No  
If yes, then please provide me the copy of supporting documents/ audio or video recording of his complaint.
- (3) Action Taken Report.

**Note:**

A. As per CIC order CIC/SS/A/2011/000863 Dated 21.09.2011, the information sought by appellant does not fall under 8(1) (j) of the RTI Act. Section 8(1) (j) exempts such information from disclosure which is personal in nature and disclosure of which cause unwarranted invasion of privacy of concerned individual. Once a complaint has been filed by an individual before the concerned authority that is competent to take action upon the said complaint then such complaint or the contents thereof can no more be termed as personal information of the person filing the complaint.

B. the CIC in its order number CIC/SS/2011/000350 Dated 17th August 2011 has clearly held that the person complained against has right to know the nature of the complaint made against him. Such documents can not be treated as personal information supplied by third party.

C. Confidentiality: - Section 11 of the RTI Act concerns such information which is treated as confidential by the third party. As, the CIC in its order number CIC/SS/2011/000350 Dated 17<sup>th</sup> August 2011 has clearly held that such documents can not be treated as personal information supplied by a third party, therefore the Respondent's PIO should not invite the Appellant's husband under Section 11 of the RTI Act to make submissions regarding whether the contents of his complaint should be disclosed to the Appellant.
