On 05.08.2017, at about 10.57 P.M., the applicant had made a complaint to Police Control Room at 100 Number regarding the cruel clutches, beatings and atrocities being faced at the hands of my husband Ram Gopal. The PCR had got lodged my said complaint at PS Bawana and the same was marked to SI Ajay for further necessary action. My husband is a drunkard person. He is neither looking-after nor maintaining me and also not giving any money to meet the house-hold expenditure. He put the whole family at the verge of starvation. Therefore, kindly provide me the following information and documents (with the provision for inspection) under the provision of Right to Information Act, 2005-

1. Certified copy of PCR Form regarding my complaint made at 100 Number on 05.08.2017 at about 10.57 P.M. through mobile No. 9990971724.
2. Certified copy of DD Number vide which my above said complaint was lodged at PS Bawana, Delhi.
3. Certified copy of my MLC alongwith opinion of the Doctors as due to beatings given by my husband on that day, I was got medically examined at Maharishi Valmiki Hospital, Pooth Khurd, Delhi.
4. Certified copy of statement(s) on which my signatures were taken by the I.O. SI Ajay Kumar at PS Bawana, Delhi.
