RTI APPLICATION

RTI Application with respect to various complaint filed till date before the Police Station Bindapur and DCP office, Dwarka Sector 19 against the below mentioned Accused(s)

Accused No.1 : Ashutosh, alias Pankaj Mishra, alias Pulkit, alias any other name acquire from time to time, R/o- B-2/62 A, East Rajapuri, Gali No-9, Delhi -110059.

Subject :- Request for below mentioned information under RTI Act. Please get the signature of the IO and the SHO for those information which have been obtained from them, because the RTI reply may be produced before the Court of Law and appealed before the CIC, if the response is not satisfactory.

RTI QUESTIONS WITH RESPECT TO THE FAILURE OF THE POLICE BEFORE THE ATTACK UPON THE COMPLAINANT ON 24.06.2016.

- (1) That before the life threatening attack upon the complainant was executed on 24th June, 2016; the complainant have informed the Police Station Bindapur about the threats and previous attacks upon the complainant vide complaint letter dated 23.01.2016 and 05.02.2016. What action were taken on these complaints?
- (2) As per evidence on record, the Accused No.1 told to the IO on 27th April 2016 that he is an engineer to show and convince the IO that he is not mentally diseased criminal. What action has been taken to verify the engineering degree certificate of the Accused No.1? Please provide a copy of the engineering degree certificate of the Accused No.1 under RTI Act.
- (3) Accused No.1 is actually involved in settling black money of the builders and property dealers. In order to hide this activity of his, he informed to the IO that he is an engineer and employed as engineer. What action has been taken to find out how Accused No.1 prepare fake documents and ID proofs to settle black money of the builders and property dealers and commit other financial frauds?
- (4) That the Accused No.1 also claimed that he is employed as engineer. What action has been taken to verify the employment of the accused no.1 as engineer?
- (5) As per evidence on record, the Accused No.4 told to the IO on 27th April 2016 that he had executed the rent agreement with the Accused No.3. Please provide a copy of the rent agreement as per RTI Act.
- (6) With whose permission the above mentioned Accused were allowed to accumulate people in large numbers inside the police station between 10 am to 11 am on 28th April 2016; when the IO have called only the complainant, the Accused No.1, 3 and 4 in the police station.

- (7) As per the evidence on record, the Accused No.1 & 2 continued to provoke large number of people accumulated by them and by leveling false allegations against the complainant between 10 am to 11 am on 28th April 2016. What action has been taken to find out the malafide intention with which the Accused No.1 & 2 continued to provoke large number of people accumulated by them between 10 am to 11 am on 28th April 2016?
- (8) What investigation has been done to find out why the Accused No.4 brought an agent of Nagar Nigam Parshad to the police station on 28th April 2016, when the Nagar nigam parshad was never called upon by the IO. Under RTI Act, please provide the name and address of the agent of the Nagar Nigam Parsad who was brought to Police station by the Accused No.4 on 28th April 2016.
- (9) What investigation has been done to find out why the Accused No.1 had brought a person named babu lal. Under RTI Act, please provide the name and address of Babu Lal who was brought to Police station by the Accused No.1 on 28th April 2016.
- (10) What investigation was done to find the malafide intention with which the Accused No.4 on the one side claimed that this is a family issue of others and on the other hand he brought an agent / representative of nagar nigam parshad?
- (11) What investigation has been done to find out how and why Nagar Nigam Parshad and Babu Lal were protecting Accused no.1 & 4 from their crimes, when they were not at all called upon by the IO.
- (12) Further from 27.04.2016 to 28.04.2016 all the accused had one full day to consolidate their conspiracy. What action has been taken to unfold those conspiracy, as a result of which they opportunistically attacked the complaint on 28.04.2016 to the extent that they could continue to do so inside the police station. What action has been taken to find out the conspiracy hatched by the above named accused between 27.04.2016 to 28.04.2016?
- (13) From 28.04.2016 to 24.06.2016 (i.e. the date of attack with sharp weapons upon the complainant), all the accused persons had 2 months time to conspire and attack the complainant. What action has been taken to find out the conspiracy hatched by the above named accused between 28.04.2016 to 24.06.2016?
- (14) It is matter of evidence on record that during the darbar of IO on 27.04.2016, the IO told the complainant to bring the Accused No.3 to his darbar on next day. Further as per evidence on record, on 28.04.2016 when the Accused No.3 appeared before the IO, and the complainant asked the IO to investigate Accused No.3; the IO replied back saying that he has called the Accused No.3 for different purpose. Please direct the IO to specify for what purpose he called upon the Accused No.3 on 28.04.2016, because as per evidence on record he did not called the Accused No.3 on 28.04.2016 to investigate upon the complaint filed by the complainant before the police station and the Hon'ble District Court of Dwarka.
- (15) As per evidence on record the Accused No.1, 2 & 4 are also operating as per their own criminal mandate according to which they are conspiring to implicate the complainant in women related crime. Few such evidence on record are from exaggerated activities by the Accused No.1, 2 & 4 inside police station on 27.04.2016 and 28.04.2016. Due to these hidden criminal intention they use Accused No.3 as their defence, and use Accused No.3 as one and only mean to offend. Probably these low grade criminals are thinking that they will escape after falsely implicating the complainant in women related crimes. What action has been taken to decipher those hidden criminal designs?

RTI QUESTIONS WITH RESPECT TO THE FAILURE OF THE POLICE AFTER THE ATTACK UPON THE COMPLAINANT ON 24.06.2016.

- (16) After execution of the life threatening attack upon the complainant by the Accused(s); the complainant have registered his complaint vide complaint letters dated 25.06.2016, 01.07.2016, 02.07.2016, 04.07.2016, 07.07.2016, 19.08.2016, 21.09.2016, 22.10.2016, 23.11.2016, 26.12.2016, 17.03.2017, 13.05.2017, 16.06.2017 and 27.07.2017; and the complainant have repeatedly requested the Police station Bindapur and the DCP office at Dwarka Sector 19 to take action and recover sharp weapons in possession with the above named accused persons with which the complainant was attacked on 24th June, 2016. What action has been taken to recover the sharp weapons from the possession of the Accused No.1, 2 & 4 with which the complainant was attacked on 24th June, 2016 by the accused criminals?
- (17) Why the police have failed to recover sharp weapons from the possession of the accused even when name address and phone number of the criminals are made available to the Police; and more then 13 months have already passed since the attack. (Note : Please give details of action taken till date only)
- (18) It is evidence on record that the IO (named Jasbir) have forced the complainant to give it in writing that "there is no witness" of the attack on 24.06.2016 when the complainant approached the police for action. Please provide the certified copies of the complaint dated 25.06.2016 in which the IO forced the complainant to write that "there is no witness" (This complaint is in record with the Police station).
- (19) Please let me know the Rules, regulation and any other provisions of the Delhi Police Act or any other Act in accordance to which the IO forced the complainant to write that 'there is no witness'.
- (20) It is evidence on record that at the time when the IO had forced the complainant to give it in writing that "there is no witness", he also stated that it is his job to find out witness. Please provide the details of action taken in past 1 year by the IO in search of witness for the said incident. (Please specify the action taken till date to collect witness/evidence to be produced before the court)
- (21) The police station at Bindapur refused to accept the complaint dated 04.07.2016. As a result of which the complainant had to give the same and future complaint to the DCP office. Please let me know the Rules, regulation and any other provisions of the Delhi Police Act or any other Act in accordance to which the police men / women at the police station refused to accept my complaints?
- (22) During meeting with the IO and SHO, they are claiming that this is my personal case / issue / matter. Under which section of delhi police act and other statutory laws this case (which relate to spreading hatred by above named accused against a person and then running behind that person with sharp weapons with attempt to murder him) is not a crime against the state and is a personal case of the complainant?
- (23) When the Complainant henceforward approached the IO and SHO, they told the complainant that their job is to take legal action. Please provide the details of the Legal action taken by them till date.
- (24) The police persons at Bindapur Police station claim that it is not their work to give protection to the complainant at the time of refusing to register the complaint dated 02.07.2016, 04.07.2016, 19.08.2016 and 21.09.2016 by me. This response came even when they are not been asked to give any protection. It was just another reason given to different complainant to reject registration of complaint on serious crimes. Please let me know the Rules, regulation and any other provisions of the Delhi Police Act or any other Act in accordance to which the said police persons claimed that it is not their duty to maintain law

and order.

(25) The SHO also told the complainant that he should seek protection from the court. Please let me know the Rules, regulation and any other provisions of the Delhi Police Act or any other Act in accordance to which the SHO is asking the complainant to seek protection from the court when the action is required from the police station to recover sharp weapons with which the complainant was attacked.

(26) It is well established fact that and is a matter of record that till date the said IO (named jasbir) could not even locate the address of the accused despite the providing of address, phone number and name of the accused. Please provide the recording, pictures of the IO with the address location of the accused No.1, 2 & 3 so that it can be ascertained that the IO is capable of collecting witness/evidence as claimed by him on 25.06.2016 for the attack on 24.06.2016.

(27) What action has been taken to identify the role of that time Nagar nigan parshad Desh Raj raghav in supplying sharp weapons and people while attacking the complainant on 24.06.2016.

(28) What action has been taken to find out the criminal and immoral services provided by the Accused No.4 to Nagar Nigam parshad in return of which he supplied the Accused No.4 with sharp weapons and people to attack on the complainant.

(29) What investigation has been done to find out how Accused No.1 & 2 act as criminal agent for various 'netas' as a result of which they have elevated status in society and because of which they bring person like Babu lal to police station and people of different caste and communities are "do takke ka aadmi" for them (as per evidence on record)?

(30) What action has been taken to find out the place where these criminals are trained to first spread hatred and then run behind human beings belonging to different orientation, belief, caste and communities with sharp weapons after getting the first opportunity.

(31) It is well established fact that the Accused No.2 is involved in all kind of criminal and immoral activities during the past 30 – 35 years in order to serve the local netas and draw illegal benefit from them. What investigation has been done to find out how Accused No.1, 2 & 4 act as criminal agent for various 'netas' and are thus partners in looting public and government funds?

(32) After their failed attempt to attack upon the life of the complainant on 24.06.2016, all the above named accused are continuing to hatch conspiracy to attack the complainant on first opportunity due to utter frustration that is evident and recorded as evidence on record. What action has been taken to find out the conspiracy hatched by the above named accused from 24.06.2016 to till date?

(33) In order to serve which mandate of the Delhi Police Act or any other Act the police at Bindapur (through its act of omission and commission) is giving criminal protection to the above mentioned communally minded criminals.

RTI QUESTIONS WITH RESPECT TO THE MODUS OPERENDI OF CRIMES BY THE LOW GRADE CRIMINAL LIKE ACCUSED NO.1 TO 4 IN THE DESIGNATED SLUM AREA OF RAJAPURI IN WHICH THE POLICE IS ALSO INVOLVED.

After the above mentioned accused failed to extort money from the complainant on 15.01.2016, and they came to know that repeated complaint had already being lodge in

police station, they started adopting charging the complainant with women related crime such as dowry demand, dowry related beatings etc so that they will now extort money from the complainant by framing charges against him in women related crime. The Accused No.1, 2 & 4 were doing it in highly professional manner which prove that they have long experience in doing such activity. Following questions need to be answered by the IO and SHO of Bindapur Police Station under RTI Act.

(34) What investigation has been done to find out how and with what malafide intention on dated 27.04.2016, both Accused No.1 & 4 continued to frame false women related charges against the complainant after getting encouragement from the IO also on 27.04.2016.

(35) As per evidence on record the Accused No.3 send the Accused No.1 with a Whatsapp message informing him about the police complaint lodge by the complainant against them. As a result they came prepared with their conspiracy that they will implicate the complainant in false women related crimes. What investigation has been done to find out the message send by the Accused No.3 to Accused No.1?

(36) As per evidence on record, the Accused No.3 was called up on 27.04.2016 and was told to come to police station on next day at 10:00am. But the Accused No.3 dropped into the Police station at 4:00pm on 27.04.2016. Under RTI Act, please confirm from the IO that the Accused No.3 met him in the Police station at 4:00pm on 27.04.2016.

(37) That as per evidence on record it is proven fact that in accordance with the well planned provocation/instigation given by Accused No.1 & 4 to the IO on 27.04.2016, the Accused No.1 alleged that complainant is harassing the Accused No.3 for Dowry. What investigation has been done by the IO to find out how much dowry money is given by the Accused No.1 as dowry and how charges can be framed against the Accused No.1 U/S 498A of IPC against the Accused No.1 for giving dowry.

(38) What action has been taken to verify the dowry amount and articles of dowry send by Accused No.1 at the time of marriage of Accused No.3?

(39) What action has been taken to verify the income and earnings sources of the Accused No.1 and Accused No.2 through which they purchased articles of dowry?

(40) What investigation has been carried out to find out that the Accused No.1 to 3 have extorted how much money from the person with whom they claimed to have married the Accused No.3, after implicating him in false women related crimes?

(41) The IO is asking the compalintant to produce recording etc. of the incidence, but he did not ask the Accused No.1 & 4 to produce recording, evidence etc for women related crimes by the complainant. Under which law of the land this biased attitude is shown by the IO?

(42) Now the days it has become a good money making business for low grade criminals to misuse women related laws. What action has been taken to find out how the above named accused including Accused No.3 are using these laws for their benefit?
