**ORDER**

**Facts:**

1. The appellant filed RTI application dated 06.07.2015 seeking information regarding the certified copy of Ration Card bearing No. ND/54/659 containing the names of Jainul Abedin Mahmud and others.
2. The responses of CPIO and FAA are not on record. The appellant filed first appeal on 11.08.2015 with the First Appellate Authority (FAA). The appellant filed second appeal on 04.01.2016 before the Commission on the ground that CPIO and FAA had not provided the information and to invoke Section 20 of the RTI Act, 2005.

**Hearing:**

3. The appellant participated in the hearing through VC. The respondent was not present in the hearing.
4. As per the fax report dated 05.07.2015 received by the Commission, the respondent stated in his written submissions that they have already sent the

required information vide letter No. 1/145/COL/CSD/DMN/RTI/2013-14/253 dated 12.08.2015 to the appellant.

5. The appellant stated that no reply has been received by him till now.

**Discussion/ observation:**

6. The respondent should provide the information once again to the appellant as per the RTI application.

**Decision:**

7. The respondent is directed to furnish the copy of information again to the appellant in respect of his RTI application dated 06.07.2015 within 15 days from the date of this order.

8. The respondent is directed to show cause within 30 days of receipt of this order why action should not be taken against him for not participating in the hearing before the Commission.

9. No further intervention by the Commission is required.

The appeal is disposed of. Copy of the order be given to the parties free of cost.
