ORDER

The captioned appeals/complaints are pending with the Commission for adjudication; however complaint/appeal files are not available in the Commission. In terms of the decision taken in Commission's meeting dated **21.03.2017**, the matter was taken up by the Registrar of this Commission with the concerned parties to provide the relevant documents so as to enable the Commission to reconstruct files and taking up the same for adjudication. However, as per office report, no reply has been received in the captioned cases from either side.

Further, a public notice was put up on the Commission's notice board on 08.05.2017 affording another opportunity to provide the copies of relevant

documents within a period of 30 days. Despite this, the parties have not exhibited their willingness to pursue the respective matters.

In this factual backdrop, the present appeal/complaints are placed before the Commission on the reference of registry. Despite sufficient opportunity, the parties hereto have not taken any step further and thus, the Commission deems it appropriate to close the captioned cases.

The captioned cases are dismissed *in limine* for non prosecution.

Considering the bulk of cases and the acquiesce of the parties hereto, the present order shall be hosted on Commission's website and the requirement of sending individual intimation is dispensed with.
