The complainant had sought details of 99 employees, copy of notification, application, appointment letter and joining letter.

**Grounds for Complaint**

The CPIO did not provide the desired information.

**Interim Order**

**Complainant** : **Present**  
**Respondent** : **CPIO, Absent in Firozpur (in 005)**

During the hearing the complainant submitted that the entire information sought for was related to the Firozpur Division. No CPIO/PIO/rep. of Firozpur was present at the hearing despite valid and timely notice. It was a complaint case. This behaviour of the respondent CPIO is deplorable. A written explanation is called from the present CPIO to explain why he or his representative was not present at the hearing to plead the case.

The CPIO's reply is also not on record

**A Show Cause Notice is issued to the then CPIO.** The said Show Cause notice is to be served through the present CPIO to the then CPIO or CPIOs. The explanation to the said Show Cause Notice is to be submitted to the Commission within 21 days of the receipt of the order. The concerned CPIO should also explain as to why action should not be initiated against him for non supply of the sought for information. On receipt of the explanation to the Show Cause Notice, further action as deemed appropriate will be taken.

**The case is adjourned.**
