**Information sought and background of the case:**

The complainant vide RTI application dated 21.08.2015 sought information under 12 points regarding Mr. Raj Kumar who is working as a Head Clerk in the office of Medical Council of India, Pkt. -14, Sector-VIII, Dwarka, New Delhi. CPIO did not respond to the RTI application. The complainant preferred first appeal but the same remained unheard. Feeling aggrieved the complainant approached the Commission.

**Relevant facts emerging during hearing:**

The complainant chose to remain absent despite notice. The respondent is present and heard. The respondent in his reply quoted the refusal by the 3<sup>rd</sup> party about whom the information was sought. Accordingly the information was not provided and the decision of CPIO was endorsed by the FAA. The Commission enquired as to why basic information with respect to the officer concerned was not provided like date of recruitment, modes of selection, designation, salary educational qualification. The respondent replied that it

appeared from tenor of the questions that the appellant had a personal dispute with the officer which was amply displayed by questions No. 6 to 12 and hence information was held back. The respondent expressed his apology on behalf of the CPIO and stated that information on point No. 1-5 will be provided to the appellant.

**Decision:**

After hearing parties and perusal of record, the Commission directs the public authority to provide information on points 1-5 of the RTI application with 2 weeks of receipt of this order.

The appeal is disposed of accordingly.
