DECISION

It is pertinent to mention here that despite of our due notice, neither Complainant nor the respondents appeared either in person or through someone, duly authorized by them before the Commission to press their cases. However, the Commission feels that complainant must have appeared, in such situations, to press his complaints before the Commission, after all, it is his case to be pursued strongly but complainant is also absent deliberately, despite of our due notice. Thus, it shows the intention of the complainant that he is not interested, at all, in pursuing his own cases before the Commission.
