**ORDER**

1. Shri Manoj Karwasra filed an application dated 10.11.2015 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Ministry of Home Affairs (MHA) seeking information on sixteen points pertaining to NHRC Order dated 24.02.2015 in case No. 2705/7/6/2014 directing registration of FIR and arrest of some

persons including (1) attested copy of complaint of Manoj dated 30.01.2014, (2) attested copy of entry of diary No. 1422/JR and (3) attested copy of orders as updated on official website of NHRC with date as per record dated 24.02.2014 in the beginning.

**2.** Shri Manoj Karwasra filed a complaint dated 11.12.2015 before the Commission on the grounds that the information provided by the CPIO after FAA's Order, is wrong, twisted, misleading and concealed. The complainant also states that no chance was given to him for being heard during the 1<sup>st</sup> appeal, that the Order of the FAA is totally one sided, biased and against natural justice and requested the Commission to provide complete and correct information sought by him, take penal action against the CPIO and the FAA for the delay and violation of the RTI Act and award him a compensation of at least Rs. 50,000.

**Hearing:**

**3.** The complainant Shri Manoj Karwasra was not present despite notice. The respondent Shri K.K. Shrivastava, Assistant Registrar (Law), NHRC was present in person.

**4.** The respondent submitted that point wise information of the RTI application was provided to the complainant vide letter dated 20.11.2015. The complainant was also informed that the original application dated 30.01.2014 on which case No.2705/7/6/2014 was registered in the Commission, is missing along with the case file. The complainant was also informed that the matter relating to the missing file is under investigation in NHRC. The respondent further submitted that the FAA vide order dated 01.12.2015 had informed the complainant that no order dated 24.02.2014 was passed by the Commission and an inquiry is being conducted by the Investigation Division of NHRC. The FAA also observed that whatever information was available in the record has already been furnished to the

complainant by the CPIO. Hence, no further information has to be furnished by the CPIO.

**Decision:**

**5.** The Commission, after hearing the respondent and perusing the records, observes that due information has been provided to the complainant. Hence, no further intervention of the Commission is required in the matter.

**6.** With the above observations, the appeal is disposed of.

**7.** Copy of the decision be provided free of cost to the parties.
