**ORDER**

**Facts:**

**Complaint No.CIC/BS/C/2014/000254**

1. The complainant filed RTI application dated 11.07.2014 seeking certified xerox copies of the appointment orders issued under Section 5(1) and Section 5(2) of the RTI Act, 2005 by Indian Postal Department, Government of India for appointment of CPIO at GPO, Jaipur.

2. The CPIO responded on 18.07.2014 by transferring the RTI application to concerned officer. The complainant filed complaint to the Commission on 22.09.2014 on the ground that information should be provided to him.

3. The complainant filed RTI application dated 17.07.2014 seeking information on three points viz. (i) Purchase slip of the pitchers bought by GPO, Jaipur to provide drinking water to its customers for FY 2013-14, (ii) Purchase slip of water coolers bought by GPO, Jaipur from FY 2010-11 to FY 2014-15 and (iii) Certified copy of orders issued to Engineering Section for installation of water coolers from FY 2010-11 to 2014-15.

4. The CPIO responded on 30.07.2014 by transferring the application to the concerned officer. The first appeal and the first appellate authority's response are not on record. The appellant filed complaint to the Commission on 26.09.2014 on the ground that information should be provided to him.

**Hearing:**

5. The complainant did not participate in the hearing. The respondent participated in the hearing through video conferencing.

6. The respondent stated that the complainant did not turn up personally to get the information with regard to the appointment of the CPIO, despite being called twice to attend the proceedings on 24.10.2016 and 08.11.2016. This action was taken to comply with the orders of the Commission. Even then, the sought for information regarding appointment of CPIO has been provided to him.

7. The respondent further stated that the entire sought for information regarding purchase slip of pitchers, water coolers etc. has been provided to him.

**Discussion/ observation:**

8. The action/steps taken by the respondent in dealing with the RTI applications is satisfactory.

**Decision:**

9. No further intervention of the Commission is required in the matter.

The complaints are disposed of. Copy of the order be given to the parties free of cost.
