Information sought and background of the case:

Vide RTI application dated 26.04.2016, the complainant sought following information:

1. *Please provide the information as regards to the criteria for admission to class 6th to 9th in the last 5 years. Also provide the number of seats in each class. Please also provide the copy of the same.*
2. *Please provide the information about the streams available in the school in class 11th with all the options. Also provide the number of seats in each class/stream. Please also provide the information with regard to the last 5 years.*
3. *Please provide the information as regards to the criteria for admission to class 11th mentioning the stream/branches in the last 5 years. Please also provide copy of the same.*
4. *Please provide the information whether the criteria are strictly adhered to or is compromised or relaxed in specific cases. Please also provide the information on which basis the criteria relaxed in the specified case/s in the last 5 years. Please provide copy of the same.*

5. *Please provide the information about the total number of cases in the last 5 years where the criteria was relaxed or compromised. Provide copy of the same.*
6. *Complete list with name and address of the students given admission in the last 5 years from class 6th to 9th and in class 11th. Provide copy of the same.*

The CPIO vide letter dated 23.05.2016 as under:-

1. *As per Norms set by Directorate of Education. For copy refer to Directorate of Education.*
2. *All the three streams: Science, Commerce, Humanity are available in the school. No of seats as per norms. For copy refer to Directorate of Education.*
3. *As per norms & guidelines provided by Directorate of Education. For copy refer to Directorate of Education.*
4. *Strictly adhered*
5. *N.A.*
6. *In view of the safety & security of the little children, it can't be disclosed.*

Dissatisfied with the response received from CPIO, the complainant filed first appeal. Feeling aggrieved, the complainant approached the Commission.

Relevant facts emerging during hearing:

At 11:00 am:

The Complainant is absent despite notice. Respondents are present. The matter is being passed over.

At 12:35 pm:

The Complainant is absent. The Respondents are present and heard. The PIO states that the respondent school is a private Govt. aided school. He states that the information as available on record was furnished to the complainant within the statutory time frame and the reasons for discontentment are thus, not known to him. He states that the school does not have any norms regarding the academics & admissions and it follows the norms prescribed by Department of Education, GNCTD. As against the query under point no. 6, the respondent states that disclosing name, addresses of all pupils admitted in school for last 5 years is neither feasible owing to sheer volume nor lawful in view of Section 8(1)(g) of the RTI Act.

Despite second call, the complainant remained absent and her views could not be ascertained.

Decision:

After hearing the respondent and perusal of record, the Commission finds that the present complaint does not fulfil either of the ingredients mandated u/ 18 of RTI Act. The Commission concludes that the RTI application has been dealt with adequately.

The complaint is disposed of.
